

(2026/04/30 6pm) MoneyHero x Airwallex 企業帳戶

1. 合資格客戶 成功通過MoneyHero申請指定銀行帳戶並完成本條款及細則所載的其他要求的合資格客戶將獲得推廣獎賞(定義如下)。

2. 推廣期

除非另有說明, 推廣期為 2026/04/30 6pm 至 2026/05/29 6pm(包括首尾兩天) (“推廣期”)。

3. 推廣活動相關定義

- a. “指定銀行帳戶”指 Airwallex企業帳戶。
- b. “銀行帳戶提供者”指 Airwallex。
- c. “新客戶”指在申請指定銀行帳戶前 12 個月內未持有Airwallex任何銀行帳戶的客戶。
- d. “合資格簽賬”指 USD\$30 (等於HK\$234)。

4. 合資格客戶條件

4. Eligible Customers

- d. Fully complete and submit the MoneyHero Reward Redemption Form within 7 days after successfully submitting the application for the Designated Bank Account; and
