

MoneyHero x Mox 條款及細則 - 「額外 HK\$200 現金獎賞推廣活動」(202609)

1. 於推廣期內，透過 MoneyHero 指定連結申請指定帳戶，並獲批核且完成本條款列明的其他要求之合資格客戶，將可獲得由 MoneyHero 提供的 HK\$200 現金獎賞(定義如下)。

2. 推廣期

除非另有說明，本推廣活動的推廣期為 **2026年9月1日** 至 **2026年9月30日**，包括首尾兩日(以下稱「推廣期」)。

3. 本推廣活動而言：

- a. 「指定帳戶」是指 **Mox 戶口 / Mox 信用卡**。
- b. 「相關金融機構」是指 **Mox Bank Limited**(「Mox」)。
- c. 「新客戶」是指在使用指定邀請碼開立 Mox 戶口前 12 個月的任何時間，未曾以其名義持有 Mox 戶口之客戶。即使客戶未曾使用其舊有的 Mox 戶口進行任何交易，亦會被視為曾持有 Mox 戶口。
- d. 「指定邀請碼」是指「**MOXPHONEMH**」/「**MOXFLASHMH1**」/「**MOXFLASHMH2**」。
- e. Mox 就指定邀請碼提供之迎新優惠並不屬於本條款所述由 MoneyHero 提供之 HK\$200 現金獎賞。相關 Mox 迎新優惠及其條款及細則請分別參閱：

4. 合資格客戶

為獲得本推廣活動之 HK\$200 現金獎賞並成為「合資格客戶」，客戶需：

- a. 成為年滿18歲或以上、持有有效香港身份證並擁有香港通訊地址的新客戶；
- b. 在被重新導向至相關金融機構網站之前，向 MoneyHero 提供有效的電郵地址；
- c. 在推廣期內透過 MoneyHero 指定連結完整填寫並使用指定邀請碼提交指定帳戶申請；
- d. 開戶後30日內成功獲批 Mox 信用卡(批核以 Mox 系統紀錄為準)；
- e. 關於合資格消費：
 - i. 如客戶選擇指定邀請碼「**MOXPHONEMH**」&「**MOXFLASHMH1**」相關優惠：成功批卡後30日內，以 Mox 信用卡完成合資格消費累積滿指定金額(按「指定邀請碼」之相關條款細則內「簽賬任務」而定)；

- ii. 如客戶選擇指定邀請碼「**MOXFLASHMH2**」相關優惠：無簽賬要求；及
- f. 完成上述合資格消費要求（如適用）後，客戶將收到包含「成功申請編號」之通知。客戶須於收到「成功申請編號」後14日內填妥及提交 MoneyHero「獎賞換領表格」。

5. 推廣獎賞及兌換

- a. 完成上述第4條所有條件的合資格客戶，將可獲得 **HK\$200** 現金獎賞（經轉數快 **FPS** 發放）（「現金獎賞」），由 MoneyHero 提供。
- b. 每位合資格客戶於本推廣活動最多可獲得 1 份現金獎賞。

 - i. 須使用提供予 MoneyHero 之電話號碼註冊 FPS；
 - ii. 同意透過 FPS 接收現金獎賞；
 - iii. 須全權負責確保提供予 MoneyHero 之電話號碼已註冊 FPS，並為其本人名下 FPS 帳戶之正確電話號碼；及
 - iv. 確認並同意一旦提交 MoneyHero 獎賞換領表格，提供之電話號碼不可更改，若提供錯誤電話號碼，現金獎賞將不會重新發放。
- g. 合資格客戶接受現金獎賞，即確認其遵守所有適用的反洗錢(AML)法律及法規。MoneyHero 保留權利，若懷疑違反反洗錢要求，或 FPS 帳戶資料與合資格客戶之資料不符，可扣留或取消任何現金獎賞。MoneyHero 對因合資格客戶提供不正確或第三方帳戶資料而引致之任何損失或問題概不負責。
- h. 成功申請指定帳戶並提交 MoneyHero 獎賞換領表格，但最終未獲相關金融機構批核的用戶，將無法獲得現金獎賞。
- i. 未在指定期限內提交 MoneyHero 獎賞換領表格的用戶，即使滿足所有其他條件，亦無法獲得現金獎賞。
- j. 在 MoneyHero 獎賞換領表格提供不準確或錯誤資料的用戶（由 MoneyHero 全權酌情決定）將無法獲得現金獎賞。

- k. 任何產品的最終批核均由相關金融機構全權酌情決定, 並受其信貸及風險審批標準所約束。參加本推廣活動並不保證任何所申請產品會獲批核。MoneyHero 不保證任何所申請產品會獲批核。

Terms and Conditions of MoneyHero x Mox - Extra HK\$200 Cash Reward Promotion (202609)

1. Eligible Customers who apply for a Designated Account through MoneyHero during the Promotion Period, are approved for the same and complete the other requirements set out herein will receive an HK\$200 cash reward provided by MoneyHero (as defined below).

2. Promotion Period

Unless otherwise specified, the promotion period of the Promotion is from **1 September 2026 to 30 September 2026**, both dates inclusive (the "Promotion Period").

3. For the purposes of this Promotion:

- a. "Designated Account" means the **Mox Account / Mox Credit Card**.
- b. "Product Provider" means **Mox Bank Limited ("Mox")**.
- c. "New Customer" means a customer who has not held a Mox Account in his/her name at any time in the 12 months prior to opening a Mox Account using a Designated Invitation Code. A customer is considered to have held a Mox Account even if no transaction was made on the prior Mox Account.
- d. "Designated Invitation Code" means 「**MOXPHONEMH**」/「**MOXFLASHMH1**」/「**MOXFLASHMH2**」.
- e. The welcome offers provided by Mox under the Designated Invitation Codes are separate from the HK\$200 Cash Reward provided by MoneyHero under these Terms and Conditions. Please refer to the respective Mox invitation code promotion terms and conditions below:

4. Eligible Customers

To qualify for the HK\$200 Cash Reward under this Promotion and become an "Eligible Customer", customers must:

- a. Be a New Customer who is at least 18 years old, holds a valid Hong Kong identity card, and has a Hong Kong correspondence address;
- b. Provide MoneyHero with a valid email address before being redirected to the Product Provider's website;

- c. During the Promotion Period, use the designated link through MoneyHero to complete and submit an application for a Designated Account using “Designated Invitation Code”;
- d. Successfully obtain the Mox Credit Card within 30 days after opening the account (approval is based on Mox’s system records);
- e. Regarding eligible spending:
 - i. If customer choosing Designated Invitation Code 「**MOXPHONEMH**」&「**MOXFLASHMH1**」offers: Accumulate the specified amount of eligible spending using the Mox Credit Card within 30 days after successful card approval (as specified under the “Spending Requirement” in the relevant Terms and Conditions for the applicable “Designated Invitation Code”);
 - ii. If customer choosing Designated Invitation Code「**MOXFLASHMH2**」offer: have **no Spending Requirement**; and
- f. After completing the eligible spending requirement (if applicable) above, the customer will receive a notification containing the “successful application number”. The customer must complete and submit the MoneyHero “Reward Redemption Form” within 14 days after receiving the “successful application number”.

5. Promotion Reward and Redemption

- a. Eligible Customers who complete all conditions set out in Clause 4 above will receive an **HK\$200 cash reward, distributed via Faster Payment System (“FPS”) (the “Cash Reward”)**, provided by MoneyHero.
- b. Each Eligible Customer may receive a maximum of one Cash Reward under this Promotion.
- c. After confirmation of eligibility, MoneyHero will send the relevant reward notification or redemption arrangement to the email address provided by the Eligible Customer to MoneyHero within 90 days. Eligible Customers who provide inaccurate or incorrect information (as determined by MoneyHero in its absolute discretion) will not be able to receive the Cash Reward.
- d. Eligibility for the Cash Reward will be based on the internal records of MoneyHero and the Product Provider. In the event of any dispute, MoneyHero reserves the right to make the final decision in its absolute discretion, which shall be binding on all users.
- e. If the application for the Designated Account is not made via the designated MoneyHero link, or an ad blocker, tracking blocker or incognito/private browsing mode is enabled during the application process, the application may not be counted as valid and the user may not be eligible for the Cash Reward. MoneyHero reserves the right to withhold the Cash Reward where, according to its records, the application was not made through MoneyHero in accordance with these Terms and Conditions.
- f. The Cash Reward will be distributed via FPS to the phone number provided by the Eligible Customer in the MoneyHero Reward Redemption Form. Eligible Customers:

- i. are required to have registered for FPS using the phone number provided to MoneyHero;
 - ii. agree to receive the Cash Reward via FPS;
 - iii. are fully responsible for ensuring that the phone number provided to MoneyHero is registered for FPS and is the correct phone number linked to their FPS account in their own name; and
 - iv. acknowledge and agree that once the MoneyHero Reward Redemption Form has been submitted, the phone number provided cannot be amended, and the Cash Reward will not be re-issued to Eligible Customers who have provided an incorrect phone number.
- g. By accepting the Cash Reward, Eligible Customers confirm that they are in compliance with all applicable Anti-Money Laundering (“AML”) laws and regulations. MoneyHero reserves the right to withhold or cancel the Cash Reward if it suspects any violation of AML requirements, or if the FPS account details do not match those of the Eligible Customer. - h. Users who successfully apply for a Designated Account and submit the MoneyHero Reward Redemption Form but are not approved by the Product Provider will not be able to receive the Cash Reward.
- i. Users who do not submit the MoneyHero Reward Redemption Form within the specified period will not be eligible to receive the Cash Reward, even if they fulfill all other conditions.
- j. Users who provide inaccurate or incorrect information in the MoneyHero Reward Redemption Form (as determined by MoneyHero in its absolute discretion) will not be able to receive the Cash Reward.
- k. The general redemption process set out on the MoneyHero Website shall not apply to this Promotion. The redemption process for the Cash Reward shall be governed solely by these Terms and Conditions.
- l. The redemption and fulfillment process may take at least 8 weeks starting from the date on which eligibility is confirmed by the Product Provider, depending on the actual redemption arrangements, user approval and transaction status or other factors that may affect eligibility for the Cash Reward.
- m. Any Cash Reward not claimed past the stipulated collection period (if any) will be forfeited without any liability on the part of MoneyHero to the Eligible Customer.  - i. MoneyHero sharing their personal details with the Product Provider in order to accurately confirm whether a user is eligible to receive the Cash Reward,
