

(2026/5/1 10am) MoneyHero x 美國運通白金卡

1. 成功通過 MoneyHero 申請指定信用卡並完成以下要求的合資格客戶將獲得推廣獎賞(各自定義如下)。

2. 推廣期

除非另有說明, 推廣活動的推廣期為 2026/5/1 10am 至 2026/5/29 6pm(包括首尾兩日)(「推廣期」)。

3. 推廣活動定義

a. 「指定信用卡」是指 美國運通白金卡。

b. 「信用卡提供者」是指 美國運通。

c. 「新客戶」是指在現時並未持有及於現時所申請美國運通白金卡主卡批核日起計之過去12個月內沒有取消任何美國運通白金卡主卡之申請人。

d. 「合資格消費」是指消費HK\$60,000或以上, 及已清繳年費。

4. 合資格客戶

為獲得推廣獎賞並成為「合資格客戶」, 客戶需:

a. 為年滿18歲或以上、持有有效香港身份證及香港地址的新客戶;

b. 在推廣期內通過 MoneyHero 使用指定連結完整填寫並提交指定信用卡申請;

c. 在推廣期內成功提交指定信用卡的申請後 7 天內完整填寫並提交 MoneyHero 獎賞換領表格;

d. 在2026/06/30或之前經信用卡提供者批核其指定信用卡申請, 並以信用卡提供者系統記錄為準;

b. “**Product Provider**” means American Express.

c. “**New Customer**” means who have not held The Platinum Card in the 12 months preceding the date on which their application for a Designated Credit Card is made.

d. “**Eligible Spending**” means HK\$60,000 or above.

4. Eligible Customers

In order to receive a Promotion Reward and to comprise “**Eligible Customers**”, customers are required to:

a. Be a New Customer who is aged 18 or above, a holder of a valid Hong Kong Identity Card and with a correspondence address within Hong Kong;

b. Fully complete and submit an application for a Designated Card through MoneyHero using the designated link during the Promotion Period;

c. Fully complete and submit the MoneyHero Reward Redemption Form within 7 days after successfully submitting the application of the Designated Card within the Promotion Period;

d. Have their application for the Designated Card approved by the Product Provider on or before 2026/06/30, subject to the Product Provider’s system records; and

e. Spend HK\$60,000 or above within 60 days after card issued and fully paid the annual fee

c. After confirmation of eligibility, redemption instructions will be sent to Eligible Customers via email to the email address provided by the Eligible Customer to MoneyHero within 90 days. Eligible Customers who provide inaccurate or incorrect information (as determined by MoneyHero acting in its absolute discretion) will not be able to receive any Promotion Reward.

 - (iii) are fully responsible for ensuring that the phone number provided to MoneyHero is registered for FPS and the correct phone number linked to their FPS account in their own name; and
 - (iv) acknowledge and agree that once the MoneyHero Reward Redemption Form has been submitted, the phone number provided cannot be amended, and the Cash Reward will not be re-issued to Eligible Customers who have provided incorrect phone numbers.
- h. By selecting a Cash Reward, Eligible Customers confirm that they are in compliance with all Anti-Money Laundering (AML) laws and regulations.
