

(2026/05/29 6pm) MoneyHero x Airwallex 雲匯Visa卡

1. 合資格客戶

成功通過MoneyHero申請指定信用卡並完成本條款及細則所載的其他要求的合資格客戶將獲得推廣獎賞（定義如下）。

2. 推廣期

除非另有說明，推廣期為 2026/05/29 6pm 至 2026/06/30 6pm（包括首尾兩天）（“推廣期”）。

3. 推廣活動相關定義

- a. “指定信用卡”指 Airwallex雲匯Visa卡。
- b. “信用卡提供者”指 Airwallex。
- c. “新客戶”指在申請指定信用卡前 12 個月內未持有Airwallex任何信用卡的客戶。
- d. “合資格簽賬”指 USD\$30（等於HK\$234）。

4. 合資格客戶條件

為獲得推廣獎賞並成為“合資格客戶”，客戶需：

- a. 為年滿 18 歲且持有有效香港身份證並在香港有通訊地址的新客戶；
- b. 在被重定向到信用卡提供者網站前向 MoneyHero 提供有效的電子郵件地址；
- c. 在推廣期內通過 MoneyHero 使用指定鏈接完成並提交指定信用卡的申請；
- d. 在推廣期內成功提交指定信用卡的申請後 7 天內完整填寫並提交 MoneyHero 獎賞換領表格；及

1. Eligible Customers who successfully apply for a Designated Card through MoneyHero during the Promotion Period and complete the other requirements set out herein will receive a Promotion Reward (each as defined below).

2. Promotion Period

Unless otherwise specified, the promotion period of the Promotion is from 2026/05/29 6pm to 2026/06/30 6pm, dates inclusive (the “**Promotion Period**”).

3. For the purposes of this Promotion:

a. “**Designated Card**” means the Airwallex Borderless Card.

b. “**Product Provider**” means **Airwallex**

c. “**New Customer**” means customers who have not held any credit card with Airwallex in the 12 months preceding the date on which their application for a Designated Card is made as part of this Promotion.

d. “**Eligible Spending**” means USD\$30 (equals to HK\$234).

3. Eligible Customers

In order to receive a Promotion Reward and to comprise “**Eligible Customers**”, customers are required to:

a. Be a New Customer who is aged 18 or above, a holder of a valid Hong Kong Identity Card and with a correspondence address within Hong Kong;

b. Provide a valid email address to MoneyHero prior to being redirected to the Product Provider’s website;

c. Fully complete and submit an application for a Designated Card through MoneyHero using the designated link during the Promotion Period;

d. Fully complete and submit the MoneyHero Reward Redemption Form within 7 days after successfully submitting the application of the Designated Card within the Promotion Period; and

e. Have their application for the Designated Card approved by the Product Provider and spend a minimum of USD\$30 (equals to HK\$234) in Eligible Spending using the Designated Card on or before 2026/07/31, subject to the Product Provider’s system records.

4. Promotion Rewards and Redemption

Eligible Customers who complete the conditions set out in Clause 4 above will be able to select one of the following “**Promotion Rewards**”, subject to availability:
