

# MoneyHero x BOC 條款及細則 (202607)

## 1. 合資格客戶

成功通過MoneyHero申請指定信用卡並完成本條款及細則所載的其他要求的合資格客戶將獲得推廣獎賞(定義如下)。

## 2. 推廣期

除非另有說明, 推廣期為 2026/06/30 6pm 至 2026/07/31 6pm, 包括首尾兩天(推廣期)或申請名額已滿之截止日(以較早日子為準)。

## 3. 推廣活動相關定義

- a. “指定信用卡”指 中銀 Chill World Mastercard 或 中銀 Chill Platinum Mastercard 或 中銀 Cheers Visa Infinite Card 或 中銀 Cheers Visa Signature Card 或 中銀 Bliss Card。
- b. “信用卡提供者”指 中國銀行(香港)有限公司及中銀信用卡(國際)有限公司。
- c. “新客戶”指 在現時並未持有中銀信用卡主卡或過去 12 個月內未曾持有或取消任何中銀信用卡主卡之申請人。
- d. “合資格簽賬”指需於發卡後的30日內啟動信用卡並累積合資格簽賬滿港幣 100 元或以上。合資格交易適用於零售簽賬, 惟不包括現金透支、現金存戶、未誌賬的「商戶免息分期計劃」金額、所有年費、財務費用、手續費、結餘轉戶金額、禮品換購費、以「積 FUN 錢」兌換的簽賬折扣/金額、網上繳費交易、網上繳費分期、網上支付系統繳費予指定商戶、繳稅、郵購、電話或傳真訂購、賭博交易、八達通增值、於非金融機構購買包括但不限於外匯、匯票及旅行支票、於金融機構購買包括但不限於產品、服務、存款、貸款及信貸、購買加密貨幣、電匯和匯票、購買及/或充值儲值卡/禮物卡或電子錢包、Alipay、WeChat Pay、PayMe 及 BoCPay+的交易、透過流動裝置/應用程式/電子轉賬平台進行個人對個人(P2P)的現金轉賬、禮品送貨服務費、投機買賣、其他沒有簽賬存根的零售簽賬交易、卡公司不時公佈的指定交易類別, 以及其他未經許可之簽賬。卡公司全權酌情界定合資格簽賬之定義。持卡人的主卡及其下所有附屬卡的當月累積簽賬將會合併計算。

## 4. 合資格客戶條件

為獲得推廣獎賞並成為“合資格客戶”, 客戶需:

- a. 為年滿 18 歲且持有有效香港身份證並在香港有通訊地址的新客戶, 且需符合“指定信用卡”之申請資格;

# Terms and Conditions of MoneyHero X BOC Promotion (202607)

1. Eligible Customers who successfully apply for a Designated Card through MoneyHero during the Promotion Period and complete the other requirements set out herein will receive a Promotion Reward (each as defined below).

## 2. Promotion Period

Unless otherwise specified, the promotion period of the **Promotion is from 2026/06/30 6pm to 2026/07/31 6pm**, dates inclusive or the date that the application quota is full (whichever is earlier) (the “**Promotion Period**”).

## 3. For the purposes of this Promotion:

- a. “**Designated Card**” means the **BOC Chill World Mastercard / BOC Chill Platinum Mastercard / BOC Cheers Visa Infinite Card / BOC Cheers Visa Signature Card / BOC Bliss Card**.
- b. “**Product Provider**” means **Bank of China (Hong Kong) Limited and BOC Credit Card (International) Limited**.
- c. “**New Customer**” means customers who do not currently hold or have not held/cancelled any BOC credit card in the past 12 months prior to the date of such application.
- d. “**Eligible Spending**” means activate credit card and make accumulative spending requirement of HK\$100 or above within 30 days of card issuance. Eligible Transaction includes retail transaction and excludes cash advance, Cash Before Card, unposted amount of merchant installment program, annual fee, financial fee, handling fee, balance transfer, gift redemption fee, net of amount redeemed under ‘Instant Reward’, online bill payment, online bill payment installment, payment by credit card via internet banking or online payment system to designated merchants, tax payment, mail order, telephone or fax order, casino transaction, Octopus Add Value, transaction at non-financial institutions (including but not limited to the purchase of foreign currency, money order and travelers cheque), transaction of financial institutions (including but not limited to the purchase of merchandise and services from banks, savings and loans), purchase of cryptocurrencies, wire transfer, money order, for purchase and/or reload of store-value card/gift card or e-wallet, Alipay, WeChat Pay, PayMe and BoC Pay+, person to person (P2P) fund transfer via mobile device/app/electronic platform, gift delivery charges, investment transaction, any other transaction without sales slip, any other categories as may be defined by The Company at its sole discretion from time to time and any other unauthorised transactions. - a. Be a New Customer who is aged 18 or above, a holder of a valid Hong Kong Identity Card and with a correspondence address within Hong Kong and fulfils eligibility for “Designated Card” application;
- b. Provide a valid email address to MoneyHero prior to being redirected to the Product Provider’s website;

- c. Fully complete and submit an application for a Designated Card through MoneyHero using the designated link during the Promotion Period;
- d. Fully complete and submit the MoneyHero Reward Redemption Form within 7 days after successfully submitting the application for the Designated Card within the Promotion Period;
- e. Have their application for the Designated Card approved by the Product Provider on or before 2026/08/31, subject to the Product Provider's system records; and
- f. Activate the approved Designated Card and make Eligible Spending using the Designated Card within a period of 30 days after the Designated Card is approved.

  - Marshall Emberton II Bluetooth Speaker (valued at HK\$1,499).
- b. Eligible Customers will receive a maximum of 1 Promotion Reward.
- c. After confirmation of eligibility, redemption instructions will be sent to Eligible Customers via email to the email address provided by the Eligible Customer to MoneyHero.
