

# (2026/5/15 12pm) MoneyHero x - 信銀國際大灣區雙幣信用卡

1. 成功通過 MoneyHero 申請指定信用卡並完成以下要求的合資格客戶將獲得推廣獎賞(各自定義如下)。

## 2. 推廣期

除非另有說明, 推廣活動的推廣期為 2026/5/15 12pm 至 2026/5/29 6pm(包括首尾兩日)(「推廣期」)。

## 3. 推廣活動定義

a. 「指定信用卡」是指 信銀國際大灣區雙幣信用卡。

b. 「信用卡提供者」是指 信銀國際。

c. 「新客戶」是指在現時並未持有及於現時所申請信銀國際主卡批核日起計之過去12個月內沒有取消任何主卡之申請人。

d. 「合資格消費」是指消費HK\$100。

## 4. 合資格客戶

為獲得推廣獎賞並成為「合資格客戶」, 客戶需:

- d. “**Eligible Spending**” means HK\$100.

## 4. Eligible Customers

In order to receive a Promotion Reward and to comprise “**Eligible Customers**”, customers are required to:

- a. Be a New Customer who is aged 18 or above, a holder of a valid Hong Kong Identity Card and with a correspondence address within Hong Kong;
- b. Fully complete and submit an application for a Designated Card through MoneyHero using the designated link during the Promotion Period;
- c. Fully complete and submit the MoneyHero Reward Redemption Form within 7 days after successfully submitting the application for the Designated Card within the Promotion Period;
- d. Have their application for the Designated Card approved by the Product Provider on or before 2026/06/30, subject to the Product Provider’s system records; and
- e. Fulfill eligible spending with 30 days upon card approval.

b. Eligible Customers will receive a maximum of 1 Promotion Reward.

c. After confirmation of eligibility, redemption instructions will be sent to Eligible Customers via email to the email address provided by the Eligible Customer to MoneyHero within 90 days. Eligible Customers who

provide inaccurate or incorrect information (as determined by MoneyHero acting in its absolute discretion) will not be able to receive any Promotion Reward.

- (iv) acknowledge and agree that once the MoneyHero Reward Redemption Form has been submitted, the phone number provided cannot be amended, and the Cash Reward will not be re-issued to Eligible Customers who have provided incorrect phone numbers.
