

# MoneyHero x Citi Core Cards 條款及細則 - (以下稱「推廣活動」) (202606)

## 1. 合資格客戶

成功通過MoneyHero申請指定信用卡並完成本條款及細則所載的其他要求的合資格客戶將獲得推廣獎賞(定義如下)。

## 2. 推廣期

除非另有說明, 推廣期為 2026/06/03 12pm 至 2026/06/08 6pm(包括首尾兩天) (“推廣期”)。

## 3. 推廣活動相關定義

- a. “指定信用卡”指 Citi Cash Back 信用卡 或 Citi Rewards 銀聯信用卡 或 Citi PremierMiles 信用卡 或 Citi Rewards 信用卡。
- b. “信用卡提供者”指 花旗銀行。
- c. “新客戶”指在 申請指定信用卡前 12 個月內未持有花旗銀行任何信用卡的客戶。
- d. “合資格簽賬”指 HKD\$4000。合資格簽賬之計算包括基本卡及附屬卡(如適用)之所有已誌賬的簽賬及商戶分期計劃之金額。非認可簽賬包括(但不限於) 透過快速支付系統(「轉數快」)進行之交易、八達通增值款項(包括透過電子錢包或任何其他途徑增值Smart Octopus)、現金透支、信用卡結餘轉賬之金額、折現計劃之金額、賬單「分期更好使」計劃及簽賬「分期更好使」計劃、「Quick Cash」套現分期計劃之金額、繳付予稅務局之稅項、以網上銀行或網上支付系統繳費或繳交公共事務費用、保險費用及慈善/非牟利機構交易(根據Visa、萬事達卡國際組織或銀聯(按情況適用)不時界定之商戶編號)、以「Citi PayAll服務」所繳交之費用、繳交基金之供款、銀行手續費、賭場交易、未誌賬/取消/退款的交易及其他未經許可或有舞弊/欺詐成份之簽賬。

## 4. 合資格客戶條件

為獲得推廣獎賞並成為“合資格客戶”, 客戶需:

- a. 為年滿 18 歲且持有有效香港身份證並在香港有通訊地址的新客戶 (學生恕不符合參與本次 MoneyHero推廣活動的資格);
- b. 在被重定向到信用卡提供者網站前向 MoneyHero 提供有效的電子郵件地址;
- c. 在推廣期內通過 MoneyHero 使用指定鏈接完成並提交指定信用卡的申請;
- d. 在推廣期內成功提交指定信用卡的申請後 7 天內完整填寫並提交 MoneyHero 獎賞換領表格;
- e. 在2026/07/31或之前獲信用卡提供者批准申請指定信用卡, 並以信用卡提供者系統記錄為準;
- f. 啟動已批核的指定信用卡並於指定卡獲批准後30天內使用該指定卡於「合資格簽賬」中消費滿 HKD\$4000;
- g. 成功申請是次推廣活動之指定信用卡的申請人, 就同一申請不能同時享有由MoneyHero提供的優惠和其他機構提供的優惠(包括但不限於信用卡發行者提供的迎新優惠); 及
- h. 於整個推廣期及換領期內, 合資格客戶之認可信用卡賬戶必須為有效及信用狀況良好。

\*以上禮品 (i) - (v) 限量共 500 名額，數量有限，先到先得。超出之名額將以HK\$2,200惠康購物禮券作為替補禮品。

b. 合資格客戶最多可獲得 1 項推廣獎賞。

c. 確認合資格後，兌換詳情將通過電子郵件發送到合資格客戶提供給 MoneyHero 的電子郵件地址。MoneyHero 有絕對酌情權決定的情況下，提供不準確或不正確信息的合資格客戶將無法獲得任何推廣獎賞。

d. 獲得推廣獎賞的資格將基於 MoneyHero 和信用卡提供者的內部記錄。在任何爭議情況下，MoneyHero 保留最終決定權，並對所有用戶具有約束力。

## 6. 一般推廣條款

- a. 本推廣活動由 MoneyHero Global Limited (“MoneyHero”)組織。參加本推廣活動即表示用戶同意受這些條款及細則約束。
- b. 在任何爭議情況下, MoneyHero 保留最終決定權, 並對所有用戶具有約束力。

# Terms and Conditions of MoneyHero x Citi Core Cards - (the “Promotion”) (202606)

1. Eligible Customers who successfully apply for a Designated Card through MoneyHero during the Promotion Period and complete the other requirements set out herein will receive a Promotion Reward (each as defined below).

## 2. Promotion Period

Unless otherwise specified, the promotion period of the Promotion is from 2026/06/03 12pm to 2026/06/08 6pm, dates inclusive (the “Promotion Period”).

## 3. For the purposes of this Promotion:

- a. “**Designated Card**” means **the** Citi Cash Back Card / Citi Rewards UnionPay Card / Citi PremierMiles Credit Card / Citi Rewards Card.
- b. “**Product Provider**” means **Citibank**.
- c. “**New Customer**” means customers who have not held any credit card with Citi Bank in the 12 months preceding the date on which their application for a Designated Card is made as part of this Promotion.
- d. “**Eligible Spending**” means HKD\$4000. All posted transactions and monthly installments of billed Merchant InstallmentPlan conducted by principal and supplementary card(s), if applicable, are included in the Eligible Spending calculation. Ineligible transactions, including but not limited to, transactions through Faster Payment System (FPS) services, Octopus Add Value Service transactions (including via e-wallet/ other method to top up Smart Octopus), cash advances, withdrawal amount/loan amount under the Balance Transfer Program, Cash Conversion Program, “FlexiBill” Installment Program and “PayLite” Installment Program and QuickCash Installment Program, payment to the Inland Revenue Department, online bill payment or utilities bill made with Eligible Card via internet banking or online payment system, insurance transactions and transactions on charity donations/ non-profit organisations (according to the merchant codes issued by Visa, Mastercard Worldwide or UnionPay (as applicable) from time to time), all payments made using “Citi PayAllService”, mutual funds payment, fees & charges, casino transactions, unposted/cancelled/refunded transactions, other unauthorized transactions and fraud and abuse transactions.

## 4. Eligible Customers

In order to receive a Promotion Reward and to comprise “**Eligible Customers**”, customers are required to:

- a. Be a New Customer who is aged 18 or above, a holder of a valid Hong Kong Identity Card and with a correspondence address within Hong Kong (students are not eligible for this MoneyHero promotion);
- b. Provide a valid email address to MoneyHero prior to being redirected to the Product Provider’s website;
- c. Fully complete and submit an application for a Designated Card through MoneyHero using the designated link during the Promotion Period;

- d. Fully complete and submit the MoneyHero Reward Redemption Form within 7 days after successfully submitting the application for the Designated Card within the Promotion Period;
- e. Have their application for the Designated Card approved by the Product Provider on or before 2026/07/31, subject to the Product Provider's system records;
- f. Activate the approved Designated Card and spend a minimum of HKD\$4000 in Eligible Spending using the Designated Card within a 30 day period after the Designated Card is approved;
- g. This promotion cannot be combined with any other offers. The applicant who successfully applied for the designated Card in this promotion provided by MoneyHero shall NOT be further entitled to other rewards in relation to the same application for the same Card, including but not limited to the Welcome Offers provided by the Card issuers; and
- h. Eligible Customers' Eligible Card accounts must be valid and in good standing during the entire Promotion Period and fulfillment period.

## 5. Promotion Rewards and Redemption

  - v. Apple iPad 11-inch (A16) 128GB (value of HK\$2,799); OR
  - vi. Dyson Cool™ CF1 Fan (value of HK\$2,490); OR
  - vii. HK\$2,200 Apple Store Gift Card; OR
  - viii. HK\$2,200 Wellcome Shopping Voucher; OR
  - ix. 22,000 Max Miles.

\*The above gifts (i) - (v) are limited to a total of 500 slots, with limited quantities available on a first-come, first-served basis. The excess quotas will be compensated with a HK\$2,200 Wellcome Shopping Voucher as a substitute gift.

- b. Eligible Customers will receive a maximum of 1 Promotion Reward.
- c. After confirmation of eligibility, redemption instructions will be sent to Eligible Customers via email to the email address provided by the Eligible Customer to MoneyHero. Eligible Customers who provide inaccurate or incorrect information (as determined by MoneyHero acting in its absolute discretion) will not be able to receive any Promotion Reward.
- d. Eligibility for the Promotion Reward will be based on MoneyHero and the Product Providers' internal records. In the event of any disputes, MoneyHero reserves the right to make the final decision in its absolute discretion, which shall be binding on all users.
- e. - c. MoneyHero reserves the right to amend these Terms and Conditions at any time, including changing the Promotion Period or Promotion Reward or to terminate this Promotion with or without prior notice or liability to users.
- d. In the event of any inconsistencies between these Terms and Conditions and any other materials (e.g marketing materials) relating to this Promotion, these Terms and Conditions shall prevail.
- e.
