

(2026/07/31 6pm) MoneyHero x Citi Prestige Card

1. 合資格客戶

成功通過MoneyHero申請指定信用卡並完成本條款及細則所載的其他要求的合資格客戶將獲得推廣獎賞（定義如下）。

2. 推廣期

除非另有說明，推廣期為 2026/07/31 6pm 至 2026/08/31 6pm（包括首尾兩天）（“推廣期”）。

3. 推廣活動相關定義

a. “指定信用卡”指 Citi Prestige 信用卡。

b. “信用卡提供者”指 花旗銀行。

c. “新客戶”指 除特別註明外，迎新獎賞只適用於 i) 現在不持有任何由花旗銀行所發行之Citi信用卡主卡之客戶及 ii) 由申請認可信用卡當月起計過去12個月內不曾持有及不曾取消任何由花旗銀行所發行之Citi信用卡主卡之客戶。

c. “**New Customer**” means Unless otherwise specified, the Welcome Offers are only applicable to customers who i) currently do not hold any principal card of Citi Credit Card, and ii) have not cancelled and have not held any principal card of Citi Credit Card within the past 12 months from the month of application for the Eligible Card.

d. “**Eligible Spending**” means HKD\$8,000. All posted transactions and monthly installments of billed Merchant Installment Plan conducted by principal and supplementary card(s), if applicable, are included in the Eligible Spending calculation. d. Fully complete and submit the MoneyHero Reward Redemption Form within 7 days after successfully submitting the application for the Designated Card within the Promotion Period;

e. Have their application for the Designated Card approved by the Product Provider on or before 2026/09/30, subject to the Product Provider’s system records; and
