

# (2026/2/27 6pm) MoneyHero x DBS COMPASS VISA / DBS Live Fresh Card / DBS Live Fresh College Affinity Card

## 1. 合資格客戶

成功通過MoneyHero申請指定信用卡並完成本條款及細則所載的其他要求的合資格客戶將獲得推廣獎賞(定義如下)。

## 2. 推廣期

除非另有說明, 推廣期為 2026/2/27 6pm 至 2026/3/31 6pm(包括首尾兩天) (“推廣期”)。

## 3. 推廣活動相關定義

- a. “指定信用卡”指 DBS COMPASS VISA 或 DBS Live Fresh Card 或 DBS Live Fresh 大專生信用卡。
- b. “信用卡提供者”指 星展銀行。
- c. “新客戶”指在申請指定信用卡前 12 個月內未持有星展銀行任何信用卡的客戶。

## 4. 合資格客戶條件

為獲得推廣獎賞並成為“合資格客戶”, 客戶需:

- a. 為年滿 18 歲且持有有效香港身份證並在香港有通訊地址的新客戶;
- b. 在推廣期內通過 MoneyHero 使用指定鏈接完成並提交指定信用卡的申請;
- c. 在推廣期內成功提交指定信用卡的申請後 7 天內完整填寫並提交 MoneyHero 獎賞換領表格; 及
- d. 在2026/04/30 或之前獲信用卡提供者批准申請指定信用卡, 並以信用卡提供者系統記錄為準。

1. Eligible Customers who successfully apply for a Designated Card through MoneyHero during the Promotion Period and complete the other requirements set out herein will receive a Promotion Reward (each as defined below).

## 2. Promotion Period

Unless otherwise specified, the promotion period of the Promotion is from 2026/2/27 6pm to 2026/3/31 6pm, dates inclusive (the “**Promotion Period**”).

## 3. For the purposes of this Promotion:

a. “**Designated Card**” means the DBS COMPASS VISA / DBS Live Fresh Card / DBS Live Fresh College Affinity Card.

b. “**Product Provider**” means **DBS Bank**

c. “**New Customer**” means customers who have not held any credit card with DBS Bank International in the 12 months preceding the date on which their application for a Designated Card is made as part of this Promotion.

## 4. Eligible Customers

In order to receive a Promotion Reward and to comprise “**Eligible Customers**”, customers are required to:

a. Be a New Customer who is aged 18 or above, a holder of a valid Hong Kong Identity Card and with a correspondence address within Hong Kong;

b. Provide a valid email address to MoneyHero prior to being redirected to the Product Provider’s website;

c. Fully complete and submit an application for a Designated Card through MoneyHero using the designated link during the Promotion Period;

d. Fully complete and submit the MoneyHero Reward Redemption Form within 7 days after successfully submitting the application for the Designated Loan within the Promotion Period; and

e. Have their application for the Designated Card approved by the Product Provider on or before 2026/04/30, subject to the Product Provider’s system records.

## 5. Promotion Rewards and Redemption

a. Eligible Customers who complete the conditions set out in Clause 4 above will be able to select one of the following “**Promotion Rewards**”, subject to availability:

- HK\$400 Apple Store Gift Card; OR
- HK\$400 Wellcome Shopping Voucher.

b. Eligible Customers will receive a maximum of 1 Promotion Reward.

c. After confirmation of eligibility, redemption instructions will be sent to Eligible Customers via email to the email address provided by the Eligible Customer to MoneyHero. Eligible Customers who provide inaccurate or incorrect information (as determined by MoneyHero acting in its absolute discretion) will not be able to receive any Promotion Reward.

- d. Eligibility for the Promotion Reward will be based on MoneyHero and the Product Providers' internal records. In the event of any disputes, MoneyHero reserves the right to make the final decision in its absolute discretion, which shall be binding on all users.

If the application for the Designated Card is not made via the designated link, or an ad-blocker, tracking blocker or incognito mode is enabled during the application process, it may not be counted as valid and may lead to the user not being eligible for any Promotion Reward.
