

# (2026/02/12 12pm) MoneyHero x Dah Sing Card

## 1.合資格客戶

成功通過MoneyHero申請指定信用卡並完成本條款及細則所載的其他要求的合資格客戶將獲得推廣獎賞(定義如下)。

## 2.推廣期

除非另有說明, 推廣期為 2026/02/12 12pm 至 2026/02/25 6pm(包括首尾兩天) (“推廣期”)。

## 3.推廣活動相關定義

- a.“指定信用卡”指 大新ONE+ 信用卡。
- b.“信用卡提供者”指 大新銀行。
- c.“新客戶”指在 申請指定信用卡前 12 個月內未持有大新銀行任何信用卡的客戶。

## 4.合資格客戶條件

為獲得推廣獎賞並成為“合資格客戶”, 客戶需:

- a.為年滿 18 歲且持有有效香港身份證並在香港有通訊地址的新客戶;
- b.在推廣期內通過 MoneyHero 使用指定鏈接完成並提交指定信用卡的申請;

1. Eligible Customers who successfully apply for a Designated Card through MoneyHero during the Promotion Period and complete the other requirements set out herein will receive a Promotion Reward (each as defined below).

## 2.Promotion Period

Unless otherwise specified, the promotion period of the Promotion is from 2026/02/12 12pm to 2026/02/25 6pm, dates inclusive (the “**Promotion Period**”).

### **3. For the purposes of this Promotion:**

a. “**Designated Card**” means the Dah Sing ONE+ Credit Card.

b. “**Product Provider**” means **Dah Sing Bank**.

c. “**New Customer**” means customers who have not held any credit card with Dah Sing Bank in the 12 months preceding the date on which their application for a Designated Card is made as part of this Promotion.

### **4. Eligible Customers**

In order to receive a Promotion Reward and to comprise “**Eligible Customers**”, customers are required to:

a. Be a New Customer who is aged 18 or above, a holder of a valid Hong Kong Identity Card and with a correspondence address within Hong Kong;

b. Fully complete and submit an application for a Designated Card through MoneyHero using the designated link during the Promotion Period;

c. Fully complete and submit the MoneyHero Reward Redemption Form within 7 days after receiving the MoneyHero Reward Redemption Form from MoneyHero; and

d. Have their application for the Designated Card approved by the Product Provider on or before 2026/03/31, subject to the Product Provider’s system records.

### **5. Promotion Rewards and Redemption**

a. Eligible Customers who complete the conditions set out in Clause 4 above will be able to select one of the following “**Promotion Rewards**”, subject to availability:

c. After confirmation of eligibility, redemption instructions will be sent to Eligible Customers via email to the email address provided by the Eligible Customer to MoneyHero. Eligible Customers who provide inaccurate or incorrect information (as determined by MoneyHero acting in its absolute discretion) will not be able to receive any Promotion Reward.

d. Eligibility for the Promotion Reward will be based on MoneyHero and the Product Providers’ internal records. In the event of any disputes, MoneyHero reserves the right to make the final decision in its absolute discretion, which shall be binding on all users.

e. If the application for the Designated Card is not made via the designated link, or an ad-blocker, tracking blocker or incognito mode is enabled during the application process, it may not be counted as valid and may lead to the user not being eligible for any Promotion Reward. MoneyHero reserves the right to withhold any Promotion Reward where, according to its records, the application was not made through MoneyHero in accordance with these Terms and Conditions.
