1. 合資格客戶

成功通過MoneyHero申請指定信用卡並完成本條款及細則所載的其他要求的合資格客戶將獲得推廣獎賞（定義如下）。

2. 推廣期

除非另有說明，推廣期為 2026/09/01 12pm 至 2026/09/30 6pm（包括首尾兩天）（“推廣期”）。

3. 推廣活動相關定義

- a. “指定信用卡”指 恒生MMPOWER World Mastercard。
- b. “信用卡提供者”指恒生銀行。
- c. “新客戶”指在申請指定信用卡前 12 個月內未持有恒生銀行任何信用卡的客戶。
- d. “新舊客戶合資格簽賬”指HK\$100。

4. 合資格客戶條件

為獲得推廣獎賞並成為“合資格客戶”，客戶需：

- a. 為年滿 18 歲且持有有效香港身份證並在香港有通訊地址的新客戶；

- d. Fully complete and submit the MoneyHero Reward Redemption Form within 7 days after successfully submitting the application for the Designated Loan within the Promotion Period;

- HK\$500 (Deposited via FPS Account) ("Cash Reward"); OR
- QUICO InstaCurl 32mm Auto Hair Curler (valued at HK\$529).

b. Eligible Customers will receive a maximum of 1 Promotion Reward.

c. After confirmation of eligibility, redemption instructions will be sent to Eligible Customers via email to the email address provided by the Eligible Customer to MoneyHero within 90 days. Eligible Customers who provide inaccurate or incorrect information (as determined by MoneyHero acting in its absolute discretion) will not be able to receive any Promotion Reward.
