

(2026/02/02 12pm) MoneyHero x HASE Travel+ Visa Signature Card

1. 合資格客戶

成功通過MoneyHero申請指定信用卡並完成本條款及細則所載的其他要求的合資格客戶將獲得推廣獎賞（定義如下）。

2. 推廣期

除非另有說明，推廣期為 2026/02/02 12pm 至 2026/02/27 6pm（包括首尾兩天）（“推廣期”）。

3. 推廣活動相關定義

- a. “指定信用卡”指 恆生Travel+ Visa Signature 卡。
- b. “信用卡提供者”指 恆生銀行。
- c. “新客戶”指在申請指定信用卡前 12 個月內未持有恆生銀行任何信用卡的客戶。
- d. “新舊客戶合資格簽賬”指 HK\$100。

4. 合資格客戶條件

為獲得推廣獎賞並成為“合資格客戶”，客戶需：

- a. 為年滿 18 歲且持有有效香港身份證並在香港有通訊地址的新客戶；
- b. 在被重定向到信用卡提供者網站前向 MoneyHero 提供有效的電子郵件地址；
- c. 在推廣期內通過 MoneyHero 使用指定鏈接完成並提交指定信用卡的申請；
- d. 在推廣期內成功提交指定信用卡的申請後 7 天內完整填寫並提交 MoneyHero 獎賞換領表格；
- e. 在2026/03/31或之前獲信用卡提供者批准申請指定信用卡，並以信用卡提供者系統記錄為準；及
- f. 啟動已核實的指定卡，並於指定卡獲批准後30天內，使用該指定卡於「合資格簽帳」中消費HK\$100。

5. 推廣獎賞及兌換

a. 完成第 4 條所述條件的合資格客戶可選擇以下一項“推廣獎賞”，視供應情況而定：

1. Eligible Customers

who successfully apply for a Designated Card through MoneyHero during the Promotion Period and complete the other requirements set out herein will receive a Promotion Reward (each as defined below).

2. Promotion Period

Unless otherwise specified, the promotion period of the Promotion is from 2026/02/02 12pm to 2026/02/27 6pm, dates inclusive (the “**Promotion Period**”).

3. For the purposes of this Promotion:

a. “**Designated Card**” means the HASE Travel+ Visa Signature Card.

b. “**Product Provider**” means **Hang Seng Bank**

c. “**New Customer**” means customers who have not held any credit card with Hang Seng Bank in the 12 months preceding the date on which their application for a Designated Card is made as part of this Promotion.

d. “**New and Existing Customer Eligible Spending**” means HK\$100.

4. Eligible Customers

In order to receive a Promotion Reward and to comprise “**Eligible Customers**”, customers are required to:

a. Be a New Customer who is aged 18 or above, a holder of a valid Hong Kong Identity Card and with a correspondence address within Hong Kong;

b. Provide a valid email address to MoneyHero prior to being redirected to the Product Provider’s website;

c. Fully complete and submit an application for a Designated Card through MoneyHero using the designated link during the Promotion Period;

d. Fully complete and submit the MoneyHero Reward Redemption Form within 7 days after successfully submitting the application for the Designated Loan within the Promotion Period;

e. Have their application for the Designated Card approved by the Product Provider on or before 2026/03/31, subject to the Product Provider’s system records; and

f. Activate the approved Designated Card and spend a minimum of HK\$100 in “Eligible Spending” using the Designated Card within a 30 day period after the Designated Card is approved.

5. Promotion Rewards and Redemption

a. Eligible Customers who complete the conditions set out in Clause 4 above will be able to select one of the following “**Promotion Rewards**”, subject to availability:

- HK\$500 Apple Store Gift Card; OR
- HK\$500 Wellcome Shopping Voucher.

b. Eligible Customers will receive a maximum of 1 Promotion Reward.

c. After confirmation of eligibility, redemption instructions will be sent to Eligible Customers via email to the email address provided by the Eligible Customer to MoneyHero. Eligible Customers who provide inaccurate or incorrect information (as determined by MoneyHero acting in its absolute discretion) will not be able to receive any Promotion Reward.

d. Eligibility for the Promotion Reward will be based on MoneyHero and the Product Providers' internal records. In the event of any disputes, MoneyHero reserves the right to make the final decision in its absolute discretion, which shall be binding on all users.

e. If the application for the Designated Card is not made via the designated link, or an ad-blocker, tracking blocker or incognito mode is enabled during the application process, it may not be counted as valid and may lead to the user not being eligible for any Promotion Reward.
