1.合資格客戶

成功通過MoneyHero申請指定信用卡並完成本條款及細則所載的其他要求的合資格客戶將獲得推廣獎賞（定義如下）。

2.推廣期

除非另有說明，推廣期為 2026/09/01 6pm 至 2026/09/30 6pm（包括首尾兩天）（“推廣期”）。

3.推廣活動相關定義

- a.“指定信用卡”指 恆生Travel+ Visa Signature 卡。
- b.“信用卡提供者”指 恆生銀行。
- c.“新客戶”指在申請指定信用卡前 12 個月內未持有恆生銀行任何信用卡的客戶。

4.合資格客戶條件
