

MoneyHero x HSBC 條款及細則 - (以下稱「推廣活動」) (202511)

1. 成功通過 MoneyHero 申請指定信用卡並完成以下要求的合資格指定信用卡客戶將獲得以下推廣獎賞(各自定義如下)。

2. 推廣期

除非另有說明, 推廣活動的推廣期為 2025/11/24 12pm 至 2025/11/28 11:59pm(包括首尾兩日)(「推廣期」)。

3. 推廣活動定義

- a. 「指定信用卡」是指由香港上海滙豐銀行有限公司(及其繼承人及受讓人)於香港發出的 滙豐 EveryMile信用卡。
- b. 「信用卡提供者」是指 香港上海滙豐銀行有限公司。
- c. 「全新信用卡客戶」是指於處理其合資格信用卡申請時沒有任何由香港上海滙豐銀行有限公司(及其繼承人及受讓人)批核的個人信用卡基本卡的客戶。

4. 合資格客戶

- b. 合資格客戶最多可獲得 1 項推廣獎賞。

Terms and Conditions of MoneyHero x HSBC - (the “Promotion”) (202511)

1. Eligible Customers who successfully apply for a Designated Card through MoneyHero during the Promotion Period and complete the other requirements set out herein will receive a Promotion Reward (each as defined below).

2. Promotion Period

Unless otherwise specified, the promotion period of the Promotion is from 2025/11/24 12pm to 2025/11/28 11:59pm, dates inclusive (the “Promotion Period”).

 - 8,000 Max Miles.
- b. Eligible Customers will receive a maximum of 1 Promotion Reward.
- c. After confirmation of eligibility, redemption instructions will be sent to Eligible Customers via email to the email address provided by the Eligible Customer to MoneyHero.
