

# (2026/01/01) MoneyHero x 安信銀聯卡

## 1. 合資格客戶

成功通過MoneyHero申請指定信用卡並完成本條款及細則所載的其他要求的合資格客戶將獲得推廣獎賞（定義如下）。

## 2. 推廣期

除非另有說明，推廣期為 2026/01/01 至 2026/01/31（包括首尾兩天）（“推廣期”）。

## 3. 推廣活動相關定義

a.“指定信用卡”指 安信EarnMORE銀聯鑽石卡 或 安信EarnMORE銀聯卡（適用於全日制大學/大專學生）或 安信WeWa Visa Signature卡 或 安信WeWa Visa Signature卡（適用於全日制大學/大專學生）。

b.“信用卡提供者”指安信信貸。

c.“新客戶”指並未持有安信信用卡或遞交指定信用卡申請時過去12個月內未曾持有或取消任何安信信用卡之申請人。

## 4. 合資格客戶條件

為獲得推廣獎賞並成為“合資格客戶”，客戶需：

- a. 為年滿 18 歲且持有有效香港身份證並在香港有通訊地址的新客戶；
- b. 在被重定向到信用卡提供者網站前向 MoneyHero 提供有效的電子郵件地址；
- c. 在推廣期內通過 MoneyHero 使用指定鏈接完成並提交指定信用卡的申請；
- d. 在推廣期內成功提交指定信用卡的申請後 7 天內完整填寫並提交 MoneyHero 獎賞換領表格；及
- e. 在2026/02/28或之前獲信用卡提供者批准申請指定信用卡，並以信用卡提供者系統記錄為準。

## 5. 推廣獎賞及兌換

1. Eligible Customers who successfully apply for a Designated Card through MoneyHero during the Promotion Period and complete the other requirements set out herein will receive a Promotion Reward (each as defined below).

## 2. Promotion Period

Unless otherwise specified, the promotion period of the Promotion is from 2026/01/01 to 2026/01/31, dates inclusive (the “**Promotion Period**”).

## 3. For the purposes of this Promotion:

a. “**Designated Card**” means the PrimeCredit EarnMORE UnionPay Diamond Card / PrimeCredit EarnMORE UnionPay Card for University Student / PrimeCredit WeWa Visa Signature Card / PrimeCredit WeWa Visa Signature Card for University Student.

b. “**Product Provider**” means **Prime Credit**

c. “**New Customer**” means applicants who do not currently hold or have not held/canceled any card cards issued by PrimeCredit Limited in the past 12 months prior to the date of such application for a Designated Credit Card.

## 4. Eligible Customers

In order to receive a Promotion Reward and to comprise “**Eligible Customers**”, customers are required to:

a. Be a New Customer who is aged 18 or above, a holder of a valid Hong Kong Identity Card and with a correspondence address within Hong Kong;

b. Provide a valid email address to MoneyHero prior to being redirected to the Product Provider’s website;

c. Fully complete and submit an application for a Designated Card through MoneyHero using the designated link during the Promotion Period;

d. Fully complete and submit the MoneyHero Reward Redemption Form within 7 days after successfully submitting the application for the Designated Card within the Promotion Period; and

e. Have their application for the Designated Card approved by the Product Provider on or before 2026/02/28, subject to the Product Provider’s system records.

## 5. Promotion Rewards and Redemption

a. Eligible Customers who complete the conditions set out in Clause 4 above will be able to select one of the following “**Promotion Rewards**”, subject to availability:

c. After confirmation of eligibility, redemption instructions will be sent to Eligible Customers via email to the email address provided by the Eligible Customer to MoneyHero. Eligible Customers who provide inaccurate or incorrect information (as determined by MoneyHero acting in its absolute discretion) will not be able to receive any Promotion Reward.

- d. Eligibility for the Promotion Reward will be based on MoneyHero and the Product Providers' internal records. In the event of any disputes, MoneyHero reserves the right to make the final decision in its absolute discretion, which shall be binding on all users.
