

(2026/05/29 6pm) MoneyHero x 安信銀聯卡

1. 合資格客戶

成功通過MoneyHero申請指定信用卡並完成本條款及細則所載的其他要求的合資格客戶將獲得推廣獎賞(定義如下)。

2. 推廣期

除非另有說明, 推廣期為 2026/05/29 6pm 至 2026/06/30 6pm(包括首尾兩天) (“推廣期”)。

3. 推廣活動相關定義

a. “指定信用卡”指 安信EarnMORE銀聯鑽石卡 或 安信EarnMORE銀聯卡 (適用於全日制大學/大專學生)。

b. “信用卡提供者”指安信信貸。

c. “新客戶”指並未持有安信信用卡或遞交指定信用卡申請時過去12個月內未曾持有或取消任何安信信用卡之申請人。

4. 合資格客戶條件

為獲得推廣獎賞並成為“合資格客戶”, 客戶需:

b. “**Product Provider**” means **Prime Credit**

c. “**New Customer**” means applicants who do not currently hold or have not held/canceled any card cards issued by PrimeCredit Limited in the past 12 months prior to the date of such application for a Designated Credit Card.

4. Eligible Customers

In order to receive a Promotion Reward and to comprise “**Eligible Customers**”, customers are required to:

a. Be a New Customer who is aged 18 or above, a holder of a valid Hong Kong Identity Card and with a correspondence address within Hong Kong;

b. Provide a valid email address to MoneyHero prior to being redirected to the Product Provider’s website;

c. Fully complete and submit an application for a Designated Card through MoneyHero using the designated link during the Promotion Period;

d. Fully complete and submit the MoneyHero Reward Redemption Form within 7 days after successfully submitting the application for the Designated Card within the Promotion Period; and

e. Have their application for the Designated Card approved by the Product Provider on or before 2026/07/31, subject to the Product Provider’s system records.
