

(2026/04/14 12pm) MoneyHero x Standard Chartered Cathay Pacific Mastercard / Standard Chartered Simply Cash Visa Card / Standard Chartered Smart Credit Card

1. 成功通過 MoneyHero 申請指定信用卡並完成以下要求的合資格客戶將獲得推廣獎賞(各自定義如下)。

2. 推廣期

除非另有說明, 推廣活動的推廣期為 2026/04/14 12pm 至 2026/04/21 6pm(包括首尾兩日)(「推廣期」)。

3. 推廣活動定義

c. “**New Customer**” means customers who do not currently hold and have not cancelled any principal card of Standard Chartered Credit Card or MANHATTAN Credit Card or Standard Chartered Simply Cash Visa Card or Standard Chartered Smart Credit Card issued by Standard Chartered Bank (Hong Kong) Limited in the 6 months prior to the date of approval of their current application for a Designated Card as part of this Promotion.

4. Eligible Customers
