

(2026/6/16 6pm) MoneyHero x Standard Chartered Cathay Pacific Mastercard

1. 成功通過 MoneyHero 申請指定信用卡並完成以下要求的合資格客戶將獲得推廣獎賞(各自定義如下)。

2. 推廣期

除非另有說明, 推廣活動的推廣期為 2026/6/16 6pm 至 2026/6/30 6pm(包括首尾兩日)(「推廣期」)。

3. 推廣活動定義

a. 「指定信用卡」是指渣打銀行(香港)有限公司發行的渣打國泰Mastercard 或渣打國泰Mastercard - 優先理財 或渣打國泰Mastercard - 優先私人理財。
