

(2026/09/02 12pm) MoneyHero x Standard Chartered Cathay Pacific Mastercard

1. 成功通過 MoneyHero 申請指定信用卡並完成以下要求的合資格客戶將獲得推廣獎賞(各自定義如下)。

2. 推廣期

除非另有說明, 推廣活動的推廣期為 2026/09/02 12pm 至 2026/09/10 6pm(包括首尾兩日)(「推廣期」)。

3. 推廣活動定義

b. Eligible Customers will receive a maximum of 1 Promotion Reward.

c. After confirmation of eligibility, redemption instructions will be sent to Eligible Customers via email to the email address provided by the Eligible Customer to MoneyHero within 90 days.
