

# (2026/05/29 6pm) MoneyHero x Standard Chartered Simply Cash Visa Card / Standard Chartered Smart Credit Card

1. 成功通過 MoneyHero 申請指定信用卡並完成以下要求的合資格客戶將獲得推廣獎賞(各自定義如下)。

## 2. 推廣期

除非另有說明, 推廣活動的推廣期為 2026/05/29 6pm 至 2026/06/30 6pm(包括首尾兩日)(「推廣期」)。

## 3. 推廣活動定義

a. 「指定信用卡」是指渣打銀行(香港)有限公司發行的渣打Simply Cash Visa卡或渣打Smart信用卡。

b. 「信用卡提供者」是指渣打銀行(香港)有限公司。

c. 「新客戶」是指在推廣期前6個月內未持有或取消任何渣打銀行(香港)有限公司發行的主卡渣打信用卡或渣打Simply Cash Visa卡。

## 4. 合資格客戶

b. “**Product Provider**” means Standard Chartered Bank (Hong Kong) Limited.

c. “**New Customer**” means customers who do not currently hold and have not cancelled any principal card of Standard Chartered Credit Card or Standard Chartered Simply Cash Visa Card or Standard Chartered Smart Credit Card issued by Standard Chartered Bank (Hong Kong) Limited in the 6 months prior to the date of approval of their current application for a Designated Card as part of this Promotion.

## 4. Eligible Customers

In order to receive a Promotion Reward and to comprise “**Eligible Customers**”, customers are required to:

a. Be a New Customer who is aged 18 or above, a holder of a valid Hong Kong Identity Card and with a correspondence address within Hong Kong;

b. Fully complete and submit an application for a Designated Card through MoneyHero using the designated link during the Promotion Period;

c. Fully complete and submit the MoneyHero Reward Redemption Form within 7 days after successfully submitting the application for the Designated Card within the Promotion Period;

d. Have their application for the Designated Card approved by the Product Provider on or before 2026/07/31, subject to the Product Provider’s system records; and

e. Submit [SCB Proof Submission Form](#) and upload the relevant approval documents (i) the name of the Designated Card applied for, (ii) their application date, and (iii) a screen capture of the approval SMS or email notification within 7 days of receiving approval from the Product Provider, which will be used by MoneyHero to verify reward eligibility.

- b. Eligible Customers will receive a maximum of 1 Promotion Reward.
- c. After confirmation of eligibility, redemption instructions will be sent to Eligible Customers via email to the email address provided by the Eligible Customer to MoneyHero within 90 days. Eligible Customers who provide inaccurate or incorrect information (as determined by MoneyHero acting in its absolute discretion) will not be able to receive any Promotion Reward.
- d. Eligibility for the Promotion Reward will be based on MoneyHero and the Product Providers' internal records. In the event of any disputes, MoneyHero reserves the right to make the final decision in its absolute discretion, which shall be binding on all users.
