

MoneyHero x Generali Insurance 火險推廣活動 (2026年8月至12月)(「條款及細則」)

1. 推廣內容

「2026年8 - 12月－忠意火險推廣活動」(「推廣活動」)由MoneyHero Insurance Brokers Limited(「**MoneyHero**」)代表忠意保險(香港)(「忠意」)舉辦。

根據本條款及細則，合資格用戶(定義如下)於推廣期內(定義如下)，透過MoneyHero的網站成功投保忠意之火險保障計劃(「指定保險產品」)，每張保單可獲取忠意旅遊保(全年旅遊計劃－標準計劃) 1人；(價值HK\$1,682)(「推廣獎賞」)。每個推廣時段首 10 位成功投保的用戶可獲得此獎賞，先到先得，送完即止。

2. 推廣期

除特別註明外，此次推廣期由 2026/08/01 12nn 起至 2026/12/31 6pm，包括首尾兩日。推廣期劃分為以下時段：

- 第五時段：2026/12/01 12nn 至 2026/12/31 6pm

3. 參加資格

要成為可獲取第4條所列明之「推廣獎賞」的「合資格用戶」，客戶必須於推廣期內：

- a. 為18歲或以上的香港居民；及
- b. 每時段起，為首10名透過MoneyHero的網站投保合資格產品及繳付保費(定義見下文第4條)，並須為保單主要持有人；及

MoneyHero x Generali Insurance - Fire Insurance Promotion (Aug - Dec 2026) (the “Terms & Conditions”)

1. Promotion Overview

The “2026 Aug - Dec - Generali Fire Insurance Promotion” (“**Promotion**”) is organised by MoneyHero Insurance Brokers Limited (“**MoneyHero**”) on behalf of Generali Insurance (Hong Kong) (“**Generali**”).

Eligible Customers (each as defined below) who successfully purchase a Generali Fire Insurance (the “**Eligible Product**”), within the Promotion Period (each as defined below) through MoneyHero will be entitled to receive a Generali Bravo Travel Protector (Annual Travel Plan – Standard Plan) for 1 Person (value of HK\$1,682) (the “**Promotion Reward**”) subject to these Terms & Conditions. The Promotion Reward is available on a **first-come, first-served basis**, limited to **ten (10) Eligible Customers per Promotion Period segment**, while stocks last.

2. Promotion Period

The Promotion will run from 2026/08/01 12nn to 2026/12/31 6pm, both dates inclusive (the “**Promotion Period**”). The Promotion Period is divided into the following segments:

- Period 1: 2026/08/01 12nn to 2026/09/01 12nn
- Period 2: 2026/09/01 12nn to 2026/10/01 12nn
- Period 3: 2026/10/01 12nn to 2026/11/01 12nn
- Period 4: 2026/11/01 12nn to 2026/12/01 12nn
- Period 5: 2026/12/01 12nn to 2026/12/31 6pm

3. Eligible Customers

To qualify as an “**Eligible Customers**”, a customer must during the Promotion Period:

- a. Be a resident of Hong Kong aged 18 or above;
- b. Be one of the first ten (10) customers in the relevant Promotion Period segment to successfully purchase an Eligible Product (as defined in Clause 4 below) through the MoneyHero website as the main policyholder; and
- c. Complete the purchase of an Eligible Product (as defined in Clause 4 below) through MoneyHero during the Promotion Period (including payment of the premium). If the application is not made via the designated link, or an Ad-blocker, tracking blocker or incognito mode is enabled during the application, it may not

be counted as valid and may lead to the customer not being eligible for any rewards. MoneyHero reserves the right to withhold any rewards where, according to its records, the application is not made through MoneyHero in accordance with these Terms and Conditions; and

- d. Maintain the Eligible Product in a valid state and not cancel nor be refunded based on Generali's records.
