

【出卡即出走！MoneyHero大派總值超過HK\$25萬旅費幫你「飛」】（「推廣活動」）條款及細則

1. MoneyHero Global Limited（「MoneyHero」）為本次推廣活動（「本推廣」）的主辦方。根據本推廣條款，符合資格的參加者於 MoneyHero 網站成功申請合資格產品並參與本推廣，可按本條款及細則並受名額限制獲得推廣獎賞（定義見下文）。

2. 推廣活動時間

5. 推廣獎賞及兌換

5. Promotion Rewards and Redemption

- a. - b.
