

"MOXFLASHMH1" top-up offer invitation code promotion (the "Promotion") terms and conditions 1. These terms apply to the Promotion offered by Mox Bank Limited ("Mox", "we", "us" or "our"). By participating in the Promotion, you agree to these terms. 2.
