# MoneyHero x Cashing Pro 私人貸款條款及細則 – 202512 提取貸款優惠 (「推廣活動」)

1. 客戶凡在推廣期內通過MoneyHero成功申請指定貸款並完成以下要求的合資格客戶, 將獲得推廣獎賞(定義見下文)。

### 2. 推廣期

除非另有說明, 推廣活動的推廣期為 2025/12/01 6pm 至 2025/12/31 12pm, 包括首尾兩日(「推廣期」)。

## 3. 推廣活動條款:

- a.「指定貸款」是指 Cashing Pro 特快私人貸款 或 Cashing Pro 小額應急錢 或 Cashing Pro 學生貸款 或 Cashing Pro 結餘轉戶貸款 或 Cashing Pro 公務員及專業人士貸款。
- b.「產品提供者」是指 Cashing Pro。

## 4. 合資格客戶

為了獲得推廣獎賞並成為「合資格客戶」,客戶需滿足以下條件:

- a. 為年滿18歲或以上、持有有效香港身份證及在香港有通訊地址的客戶;
- b. 在被重定向至產品提供者網站之前, 向MoneyHero提供有效的電郵地址;

## Terms and Conditions of MoneyHero x Cashing Pro Personal Loan - Drawdown Offer (202512)

1. Eligible Customers who successfully apply for a Designated Loan through MoneyHero during the Promotion Period and complete the other requirements set out herein will receive a Promotion Reward (each as defined below).

### 2. Promotion Period

Unless otherwise specified, the promotion period of the Promotion is from 2025/12/01 6pm to 2025/12/31 12pm, dates inclusive (the "**Promotion Period**").

### 3. For the purposes of this Promotion:

- **a.** "Designated Loan" means the Cashing Pro Express Personal Loan / Cashing Pro Small Emergency Loan / Cashing Pro Student Loan / Cashing Pro Debt Consolidation Loan / Cashing Pro Professional Loan.
- b. "Product Provider" means Cashing Pro.

### 4. Eligible Customers

In order to receive a Promotion Reward and to comprise "Eligible Customers", customers are required to:

- a. Be a New Customer who is aged 18 or above, a holder of a valid Hong Kong Identity Card and with a correspondence address within Hong Kong;
- b. Provide a valid email address to MoneyHero prior to being redirected to the Product Provider's website;
- c. Fully complete and submit an application for a Designated Loan through MoneyHero using the designated link during the Promotion Period and complete loan drawdown; and
- d. Fully complete and submit the MoneyHero Reward Redemption Form within 7 days after successfully submitting the application for the Designated Loan within the Promotion Period.

- c. After confirmation of eligibility, redemption instructions will be sent to Eligible Customers via email to the email address provided by the Eligible Customer to MoneyHero. Eligible Customers who provide inaccurate or incorrect information (as determined by MoneyHero acting in its absolute discretion) will not be able to receive any Promotion Reward.
