

MoneyHero x 信銀國際私人貸款 條款及細則 – 202605 提取貸款優惠(「推廣活動」)

1. 客戶凡在推廣期內通過MoneyHero成功申請指定貸款並完成以下要求的合資格客戶，將獲得推廣獎賞(定義見下文)。

2. 推廣期間

Unless otherwise specified,推廣期間為 2026/05/21 6pm 至 2026/06/01 10am(「推廣期間」)。

3. 推廣條款

- a. 「指定貸款」指 信銀國際 \$mart Plus 分期貸款 或 信銀國際 \$mart Plus 分期貸款 - 結餘轉戶。
- b. 「產品提供者」指 信銀國際。
- c. 「全新客戶」指 並非現有信銀國際貸款客戶的申請人，此推廣活動不適用於現有信銀國際貸款客戶。

4. 合資格客戶

為了獲得推廣獎賞並成為「合資格客戶」，客戶需：

- a. 為18歲或以上，持有有效香港身份證且在香港有通訊地址的客戶；

- b. 合資格客戶將最多可獲得1個推廣獎賞。

Terms and Conditions of MoneyHero x China CITIC Bank International Personal Loan - Drawdown Offer (202605) (the “Promotion”)

1. Eligible Customers who successfully apply for a Designated Loan through MoneyHero during the Promotion Period and complete the other requirements set out herein will receive a Promotion Reward (each as defined below).

2. Promotion Period

Unless otherwise specified, the promotion period of the Promotion is from 2026/05/21 6pm to 2026/06/01 10am, dates inclusive (the “Promotion Period”).

3. For the purposes of this Promotion:

- a. “**Designated Loan**” means the CNCBI \$mart Plus Personal Installment Loan / CNCBI \$mart Plus Personal Installment Loan – Debt Consolidation
- b. “**Product Provider**” means China CITIC Bank International .
- c. “**New Customers**” means applicants who are not existing loan customers of China CITIC Bank International. This promotion is not applicable to existing loan customers of China CITIC Bank International.

4. Eligible Customers

In order to receive a Promotion Reward and to comprise “**Eligible Customers**”, customers are required to:

- a. Be a Customer who is aged 18 or above, a holder of a valid Hong Kong Identity Card and with a correspondence address within Hong Kong;
- b. Fully complete and submit an application for a Designated Loan through MoneyHero using the designated link during the Promotion Period, with loan tenor of 12 months or above;
- c. Fully complete and submit the MoneyHero Reward Redemption Form within 7 days after successfully submitting the application for the Designated Loan within the Promotion Period; and
- d. Have their application for the Designated Loan approved by the Product Provider and complete drawdown for the Designated Loan within 1 month.

 - HK\$3,500 (Deposited via FPS Account) (“Cash Reward”).
 - iii. Loan amount from HK\$100,000 to HK\$299,999 + Repayment period 12 months or above:
 - HK\$2,000 Apple Store Gift Card; OR
 - HK\$2,000 Wellcome Shopping Voucher; OR
 - HK\$1,500 (Deposited via FPS Account) (“Cash Reward”).
- b. Eligible Customers will receive a maximum of 1 Promotion Reward.
 - c. After confirmation of eligibility, redemption instructions will be sent to Eligible Customers via email to the email address provided by the Eligible Customer to MoneyHero. Eligible Customers who provide inaccurate or incorrect information (as determined by MoneyHero acting in its absolute discretion) will not be able to receive any Promotion Reward.
 - d. Eligibility for the Promotion Reward will be based on MoneyHero and the Product Providers’ internal records. In the event of any disputes, MoneyHero reserves the right to make the final decision in its absolute discretion, which shall be binding on all users.
