

# MoneyHero x 富邦銀行私人貸款條款及細則 – 202511 提取貸款優惠(「推廣」)

1. 客戶凡在推廣期內通過MoneyHero指定優惠碼成功申請指定貸款並完成以下要求的合資格客戶，將獲得推廣獎賞(定義見下文)。

## 2. 推廣期間

除非另有說明，推廣期間為由 2025/10/30 6pm 至 2025/12/01 6pm(「推廣期間」)。

## 3. 推廣條款

- a. 「指定貸款」指富邦「EZ Cash」私人貸款。
- b. 「產品提供者」指富邦銀行。
- c. 「指定優惠碼」為「MHPL05」。

## 4. 合資格客戶

為了獲得推廣獎賞並成為「合資格客戶」，客戶需：

- a. 為18歲或以上，持有有效香港身份證且在香港有通訊地址的客戶；
- b. 在被重新定向到產品提供者的網站之前向MoneyHero提供有效的電郵地址；
- c. 在推廣期間內使用指定優惠碼透過MoneyHero提交指定貸款申請，還款期為12個月或以上；
- d. 在推廣期間內成功提交指定貸款的申請後7天內提交MoneyHero獎賞換領表格；及
- e. 由產品提供者批核其指定貸款申請並於1個月內完成提取貸款。

## 5. 推廣獎賞及兌換

a. 完成上述條件的合資格客戶將根據貸款金額選擇以下「推廣獎賞」之一，視供應情況而定：

# Terms and Conditions of MoneyHero x Fubon Bank Personal Loan – 202511 Drawdown Offer (the “Promotion”)

1. Eligible Customers who successfully apply for a Designated Loan through MoneyHero during the Promotion Period and complete the other requirements set out herein will receive a Promotion Reward (each as defined below).

## 2. Promotion Period

Unless otherwise specified, the promotion period of the Promotion is from 2025/10/30 6pm to 2025/12/01 6pm, dates inclusive (the “Promotion Period”).

## 3. For the purposes of this Promotion:

- a. “Designated Loan” means the Fubon “EZ Cash” Personal Loan;
- b. “Product Provider” means Fubon Bank;
- c. “Designated promo code” means MHPL05.

## 4. Eligible Customers

In order to receive a Promotion Reward and to comprise “Eligible Customers”, customers are required to:

- a. Be Hong Kong permanent residents over 18 years old and annual income at HK\$60,000 or above;
- b. Provide a valid email address to MoneyHero prior to being redirected to the Product Provider’s website;
- c. Fully complete and submit an application for a Designated Loan through MoneyHero using the designated promo code during the Promotion Period, with repayment period not less than 12 months;
- d. Fully complete and submit the MoneyHero Reward Redemption Form within 7 days after successfully submitting the application for the Designated Loan within the Promotion Period; and
- e. Have their application for the Designated Loan approved by the Product Provider and complete drawdown for the Designated Loan within one month.

## 5. Promotion Rewards and Redemption

a. Eligible Customers who complete the conditions set out in Clause 4 above will be able to select one of the following “Promotion Rewards”, depending on the loan amount, subject to availability:

i. Loan amount HK\$100,000 or above:

b. Eligible Customers will receive a maximum of 1 Promotion Reward.

- c. After confirmation of eligibility, redemption instructions will be sent to Eligible Customers via email to the email address provided by the Eligible Customer to MoneyHero. Eligible Customers who provide inaccurate or incorrect information (as determined by MoneyHero acting in its absolute discretion) will not be able to receive any Promotion Reward.
- d. Eligibility for the Promotion Reward will be based on MoneyHero and the Product Providers' internal records. In the event of any disputes, MoneyHero reserves the right to make the final decision in its absolute discretion, which shall be binding on all users.
- e. d. In the event of any inconsistencies between these Terms and Conditions and any other materials (e.g marketing materials) relating to this Promotion, these Terms and Conditions shall prevail.

e.
