

MoneyHero x 富邦「合您意」私人貸款 條款及細則 – 2025/10/30 6pm - 2025/12/01 6pm 申請獎勵 (無須提取貸款) (「推廣活動」)

MoneyHero x Fubon Perfect Fit Personal Loan - Application Incentive

1. 客戶凡在推廣期內通過MoneyHero指定優惠碼成功申請指定貸款並完成以下要求的合資格客戶，將獲得推廣獎賞(定義見下文)。

2. 推廣期

除非另有說明，推廣活動的推廣期為 2025/10/30 6pm 至 2025/12/01 6pm，包括首尾兩日(「推廣期」)。

3. 推廣條款

a.「指定貸款」是指 富邦「合您意」私人貸款。

b.「產品提供者」是指 富邦銀行。

c.「指定優惠碼」是「MHPL05」。

4. 合資格客戶

為了獲得推廣獎賞並成為「合資格客戶」，客戶需滿足以下條件：

a. 為年滿18歲及年薪達HK\$60,000或以上之香港永久性居民；

b. 在被重定向至產品提供者網站之前，向MoneyHero提供有效的電郵地址；

c. 在推廣期內通過MoneyHero使用指定優惠碼完整填寫並提交指定貸款的申請；

1. Eligible Customers who successfully apply for a Designated Loan through MoneyHero Designated Promotion Code during the Promotion Period and complete the other requirements set out herein will receive a Promotion Reward (each as defined below).

c. After confirmation of eligibility, redemption instructions will be sent to Eligible Customers via email to the email address provided by the Eligible Customer to MoneyHero. Eligible Customers who provide inaccurate or incorrect information (as determined by MoneyHero acting in its absolute discretion) will not be able to receive any Promotion Reward.

- d. Eligibility for the Promotion Reward will be based on MoneyHero and the Product Providers' internal records. In the event of any disputes, MoneyHero reserves the right to make the final decision in its absolute discretion, which shall be binding on all users.
