# MoneyHero x Mox「即時借」(稅季適用)條款及細則 – 202512提取貸款優惠 (「推廣活動」)

1. 新舊客戶凡在推廣期內通過MoneyHero指定優惠碼成功開立指定戶口,並申請指定貸款並完成以下要求的合資格客戶,將獲得推廣獎賞(定義見下文)。

## 2. 推廣期間

# 1. Eligible Customers

Who successfully apply for a Designated Loan through MoneyHero with designated promo code during the Promotion Period and complete the other requirements set out herein will receive a Promotion Reward (each as defined below).

#### 2. Promotion Period

Unless otherwise specified, the promotion period is from 2025/12/02 6pm to 2025/12/31 12pm, dates inclusive (the "**Promotion Period**").

# 3. For the purposes of this Promotion:
