

MoneyHero x Mox「即時借」(稅季適用)條款及細則 – 202601提取貸款優惠 (「推廣活動」)

1. 全新/現有客戶凡在推廣期內通過MoneyHero指定優惠碼成功開立指定戶口，並申請指定貸款並完成以下要求的合資格客戶，將獲得推廣獎賞(定義見下文)。

2. 推廣期間

除非另有說明，推廣期為 2026/01/13 6pm 至 2026/01/30 6pm(「推廣期間」)。

3. 推廣條款

- a. 「指定貸款」指 Mox「即時借」(稅季適用)。
- b. 「指定戶口」指 Mox戶口。
- c. 「產品提供者」指 Mox Bank。
- d. 「指定優惠碼」指「MHCASH10」。
- e. 「全新客戶」指在使用「指定優惠碼」開立你的 Mox 戶口前 12 個月的任何時間，你沒有以你的名義持有 Mox 戶口。儘管你未曾使用你舊有的 Mox 戶口進行任何交易，你亦會被視為持有 Mox 戶口。
- f. 「現有客戶」指已持有 Mox 戶口並不是經「指定優惠碼」開戶。

4. 合資格客戶

為了獲得推廣獎賞並成為「合資格客戶」，客戶需：

- a. 為18歲或以上，持有有效香港身份證且在香港有通訊地址的客戶；
- b. 全新客戶於推廣期內經MoneyHero「指定優惠碼」成功開戶，並於推廣期內成功申請Mox「即時借」(稅季適用)貸款，選擇貸款額 HK\$70,000以上(批核以銀行系統紀錄為準)，並成功提取貸款。一經批核，新客戶將於申請貸款的30個工作天內收到Mox Bank發出的兌換碼電郵後(內有“7位字母和數字組成”的兌換碼)，請於收到14日內填妥「獎賞換領表格」；

- b. 合資格客戶將最多可獲得1個推廣獎賞。
- c. 在確認資格後，兌換詳情將通過電子郵件發送至合資格客戶提供給MoneyHero的電郵地址。提供錯誤或不正確信息（由MoneyHero絕對酌情決定）的合資格客戶將無法收到任何推廣獎賞。

Terms and Conditions of MoneyHero x Mox Instant Loan (Suitable for Tax Season) – 202601 Drawdown Offer (the “Promotion”)

1. Eligible Customers

Who successfully apply for a Designated Loan through MoneyHero with designated promo code during the Promotion Period and complete the other requirements set out herein will receive a Promotion Reward (each as defined below).

2. Promotion Period

Unless otherwise specified, the promotion period is from 2026/01/13 6pm to 2026/01/30 6pm, dates inclusive (the “**Promotion Period**”).

3. For the purposes of this Promotion:

- a. “**Designated Loan**” means the Mox Instant Loan (Suitable for Tax Season).
- b. “**Designated Account**” means Mox Bank Account.
- c. “**Product Provider**” means Mox Bank.
- d. “**Designated promo code**” means MHCASH10.
- e. “**New customer**” means customers who have not held a Mox Account in your name at any time in the 12-month prior to your Joining Day. You are considered to have held a Mox Account even if you haven’t completed any transactions on your prior Mox Account.
- f. “**Existing customer**” means you have held a Mox Account and you did not opened the Mox Account with the designated promo code.

4. Eligible Customers

In order to receive a Promotion Reward and to comprise “**Eligible Customers**”, customers are required to:

- a. Be a customer who is aged 18 or above, a holder of a valid Hong Kong Identity Card and with a correspondence address within Hong Kong;
- b. New customers who, during the Promotion Period, successfully open an account via MoneyHero using the designated promo code, and within the Promotion Period successfully apply for a Mox Instant Loan (Suitable for Tax Season), selecting a loan amount of HK\$70,000 or above (subject to the bank’s system approval records), and successfully drawdown the loan, shall be eligible for the reward. Upon loan approval, new customers will receive a redemption code email issued by Mox Bank within 30 working days from the loan application date (containing a 7-character alphanumeric redemption code). Customers must complete and submit the Reward Redemption Form within 14 days upon receipt of the redemption code.
- c. Existing customers will not receive a redemption code email from Mox Bank. They are only required to indicate “MoneyHero” in the relevant field of the Reward Redemption Form and provide the necessary contact information.

 - iii. Loan amount HK\$300,000 - HK\$499,999:
 - HK\$2,500 Apple Store Gift Card; OR
 - HK\$2,500 Wellcome Shopping Voucher.
 - iv. Loan amount HK\$70,000 - HK\$299,999:
 - HK\$1,000 Apple Store Gift Card; OR
 - HK\$1,000 Wellcome Shopping Voucher.
- b. Eligible Customers will receive a maximum of 1 Promotion Reward.
- c. After confirmation of eligibility, redemption instructions will be sent to Eligible Customers via email to the email address provided by the Eligible Customer to MoneyHero. Eligible Customers who provide inaccurate or incorrect information (as determined by MoneyHero acting in its absolute discretion) will not be able to receive any Promotion Reward.
- d. Eligibility for the Promotion Reward will be based on MoneyHero and the Product Providers’ internal records. In the event of any disputes, MoneyHero reserves the right to make the final decision in its absolute discretion, which shall be binding on all users.
- e.
