

# MoneyHero x OCBC華僑銀行私人貸款 條款及細則 202604 申請獎賞優惠 (無須提取貸款) (「推廣活動」)

1. 客戶凡在推廣期內通過MoneyHero成功申請指定貸款並完成以下要求的合資格客戶，將獲得推廣獎賞(定義見下文)。

## 2. 推廣期

除非另有說明，推廣活動的推廣期為 2026/03/31 6pm 至 2026/04/30 6pm，包括首尾兩日(「推廣期」)。

## 3. 推廣活動相關定義

- a. 「指定貸款」指 OCBC 華僑銀行「零息稅貸」稅務貸款 或 OCBC 華僑銀行 結餘轉戶私人貸款。
- b. 「產品提供者」指 OCBC 華僑銀行(香港)有限公司。

## 4. 合資格客戶

為了獲得推廣獎賞並成為「合資格客戶」，客戶需滿足以下條件：

- a. 為年滿18歲或以上、持有有效香港身份證及在香港有通訊地址的客戶；
- b. 在推廣期內通過MoneyHero指定連結完整填寫並提交指定貸款的申請；
- c. 在推廣期內成功提交指定貸款的申請後7天內完整填寫並提交MoneyHero獎賞換領表格；及
- d. 客戶需同時向機構交齊所有文件並獲銀行確認其貸款申請。

# Terms and Conditions of MoneyHero x OCBC - Personal Loan - Application Incentive Offer (202604)

1. Eligible Customers who successfully apply for a Designated Loan through MoneyHero during the Promotion Period and complete the other requirements set out herein will receive a Promotion Reward (each as defined below).

## 2. Promotion Period

Unless otherwise specified, the promotion period of the Promotion is from 2026/03/31 6pm to 2026/04/30 6pm, dates inclusive (the “**Promotion Period**”).

## 3. For the purposes of this Promotion:

- a. “**Designated Loan**” means the OCBC Bank "Interest-Free" Tax Loan / OCBC Bank Balance Transfer Personal Loan.
- b. “**Product Provider**” means OCBC Bank.

## 4. Eligible Customers

In order to receive a Promotion Reward and to comprise “**Eligible Customers**”, customers are required to:

- a. Be a New Customer who is aged 18 or above, a holder of a valid Hong Kong Identity Card and with a correspondence address within Hong Kong;
- b. Fully complete and submit an application for a Designated Loan through MoneyHero using the designated link during the Promotion Period; and
- c. Fully complete and submit the MoneyHero Reward Redemption Form within 7 days after successfully submitting the application for the Designated Loan within the Promotion Period; and
- d. Submit all documents to the Product Provider and have their application for the Designated Loan confirmed by the Product Provider.

## 5. Promotion Rewards and Redemption

- a. Eligible Customers who complete the conditions set out in Clause 4 above will be able to select one of the following “**Promotion Rewards**”, subject to availability:
  - HK\$500 Wellcome Shopping Voucher; OR
  - HK\$500 Apple Store Gift Card; OR
  - HK\$400 (Deposited via FPS Account) (“Cash Reward”).
- b. Eligible Customers will receive a maximum of 1 Promotion Reward.
- c. After confirmation of eligibility, redemption instructions will be sent to Eligible Customers via email to the email address provided by the Eligible Customer to MoneyHero. Eligible Customers who provide

inaccurate or incorrect information (as determined by MoneyHero acting in its absolute discretion) will not be able to receive any Promotion Reward.

- d. Eligibility for the Promotion Reward will be based on MoneyHero and the Product Providers' internal records. In the event of any disputes, MoneyHero reserves the right to make the final decision in its absolute discretion, which shall be binding on all users.
- e. If the application for the Designated Loan is not made via the designated link, or an ad-blocker, tracking blocker or incognito mode is enabled during the application process, it may not be counted as valid and may lead to the user not being eligible for any Promotion Reward. MoneyHero reserves the right to withhold any Promotion Reward where, according to its records, the application was not made through MoneyHero in accordance with these Terms and Conditions.
- f. Promotion Rewards are not refundable nor exchangeable for cash or other rewards. All products and services relating to the Promotion are available while stocks last. Eligible Customers are responsible for checking the quality of the Promotion Rewards at the time of redemption. MoneyHero shall have no legal liability relating to any aspects of the Promotion Rewards including but not limited to their quality, supply, delivery or maintenance.
- g. The Cash Reward will be distributed via FPS to the phone number provided by the Eligible Customer in the MoneyHero Reward Redemption Form. Eligible Customers:
  - (i) are required to have registered for FPS using the phone number provided to MoneyHero;
  - (ii) agree to receive the Cash Reward via FPS;
  - (iii) are fully responsible for ensuring that the phone number provided to MoneyHero is registered for FPS and the correct phone number linked to their FPS account in their own name; and
  - (iv) acknowledge and agree that once the MoneyHero Reward Redemption Form has been submitted, the phone number provided cannot be amended, and the Cash Reward will not be re-issued to Eligible Customers who have provided incorrect phone numbers.
- h. By selecting a Cash Reward, Eligible Customers confirm that they are in compliance with all Anti-Money Laundering (AML) laws and regulations. MoneyHero reserves the right to withhold or cancel any Promotion Reward (including any Cash Reward) if it suspects any violation of AML requirements, or if the FPS account details do not match those of the Eligible Customer. MoneyHero shall not be liable for any losses or issues arising from incorrect or third-party account information provided by the Eligible Customer.
- i.
