

# MoneyHero x 安信信貸 私人貸款條款及細則 – 202605 貸款優惠 (須提取貸款) (「推廣活動」)

1. 客戶於推廣期內經指定MoneyHero網頁成功申請安信信貸私人貸款(「指定貸款」), 其貸款申請獲安信信貸確認, 及成功遞交MoneyHero獎賞換領表格方可獲享優惠。

## 2. 推廣期

除非另有說明, 推廣活動的推廣期為 2026/05/01 10am 至 2026/05/31 11:59pm, 包括首尾兩日(「推廣期」)。

## 3. 推廣條款

- a. 「指定貸款」指 安信 定額私人貸款 / 安信 結餘轉戶計劃 / 安信 業主私人貸款 / 安信 公務員及專業人士貸款 / 安信免抵押汽車貸款。
- b. 「貸款提供者」安信信貸。

## 4. 合資格客戶

為了獲得推廣獎賞並成為「合資格客戶」, 客戶需滿足以下條件:

- a. 為年滿18歲或以上、持有有效香港身份證及在香港有通訊地址的客戶;
- b. 在推廣期內通過MoneyHero使用指定鏈接完整填寫並提交指定貸款的申請;
- c. 在推廣期內成功提交指定貸款的申請后7天內完整填寫並提交MoneyHero獎賞換領表格;

# Terms and Conditions of MoneyHero x PrimeCredit Personal Loan – 202605 Drawdown Offer (the “Promotion”)

1. Customers who successfully apply for a PrimeCredit Personal Loan (a “Designated Loan”) via MoneyHero, have their application for a Designated Loan confirmed by PrimeCredit, and submit the MoneyHero Reward Redemption Form within the specified period will receive a Promotion Reward.

## 2. Promotion Period

Unless otherwise specified, the promotion period of the Promotion is from 2026/05/01 10am to 2026/05/31 11:59pm, dates inclusive (the “Promotion Period”).

## 3. For the purposes of this Promotion

- a. **“Designated Loan”** means to PrimeCredit Fixed Loan / PrimeCredit Balance Transfer / PrimeCredit Property Owner Personal Loan / PrimeCredit Civil Servant & Professional Loan / PrimeCredit Unsecured Car Loan.
- b. **“Product Provider”** means PrimeCredit.

## 4. Eligible Customers

In order to receive a Promotion Reward and to comprise **“Eligible Customers”**, customers are required to:

- a. Be a Customer who is aged 18 or above, a holder of a valid Hong Kong Identity Card and with a correspondence address within Hong Kong;
- b. Fully complete and submit an application for a Designated Loan through MoneyHero using the designated link during the Promotion Period;
- c. Fully complete and submit the MoneyHero Reward Redemption Form within 7 days after successfully completing the application for the Designated Loan during the Promotion Period;
- d. Submit all documents to the Product Provider and have their application for the Designated Loan confirmed by the Product Provider, and complete drawdown; and
- e. Provide the correct format of Application Reference No while submitting redemption form, this no, can be found on the Thank You page after complete application is submitted. (Example: STAxXXXXXXXXXX).

- c. After confirmation of eligibility, redemption instructions will be sent to Eligible Customers via email to the email address provided by the Eligible Customer to MoneyHero.   - (iii) are fully responsible for ensuring that the phone number provided to MoneyHero is registered for FPS and the correct phone number linked to their FPS account in their own name; and
  - (iv) acknowledge and agree that once the MoneyHero Reward Redemption Form has been submitted, the phone number provided cannot be amended, and the Cash Reward will not be re-issued to Eligible Customers who have provided incorrect phone numbers.
