

MoneyHero x 邦民日本財務私人貸款 條款及細則 – (須提取HK\$10,000或以上貸款額) (「推廣活動」)

1. 合資格全新客戶凡在推廣期內通過MoneyHero成功申請指定貸款並成功提取HK\$10,000或以上貸款額, 以及完成以下要求的合資格客戶, 將獲得推廣獎賞(定義見下文)。
2. 推廣期
 - a. 除非另有說明, 推廣活動的推廣期為 2026/04/01 10:00 AM 至 2026/06/30 23:59, 包括首尾兩日(「推廣期」)。
3. 本推廣活動而言:
 - a. 「指定貸款」指 邦民特快私人貸款 或 邦民特快低息貸款 或 邦民低息結餘轉戶貸款 或 邦民特快私人貸款(汽車貸款適用)。
 - b. 「貸款提供者」指 邦民日本財務。
4. 合資格客戶

- b. 合資格客戶將最多可獲得1個推廣獎賞。
- c. 在確認資格後, 兌換詳情將通過電子郵件發送至合資格客戶提供給MoneyHero的電郵地址。提供錯誤或不正確信息(由MoneyHero絕對酌情決定)的合資格客戶將無法收到任何推廣獎賞。

Terms and Conditions of MoneyHero x Promise Personal Loan – (Drawdown of HK\$10,000 or above is required) (the “Promotion”)

1. Eligible Customers who successfully apply for a Designated Loan through MoneyHero and complete drawdown of HK\$10,000 or above plus the other requirements set out herein during the Promotion Period will receive a Promotion Reward (each as defined below).
2. **Promotion Period**
 - a. Unless otherwise specified, the promotion period of the Promotion is from 2026/04/01 10:00 AM to 2026/06/30 23:59 both dates inclusive (the “**Promotion Period**”).

4. **Eligible Customers**
 - a. In order to receive a Promotion Reward and to comprise “**Eligible Customers**”, customers are required to:
 - i. Be an eligible new customer of Promise who is aged 18 or above, a holder of a valid Hong Kong Identity Card and with a correspondence address within Hong Kong;

 3. HK\$2,500 (Deposited via FPS Account) ("Cash Reward").
 - iii. Loan amount HK\$100,000 or above:
 1. HK\$3,500 Wellcome Supermarket Shopping Voucher; OR
 2. HK\$3,500 HKTVmall e-Voucher; OR
 3. HK\$3,500 (Deposited via FPS Account) ("Cash Reward").
- b. Eligible Customers will receive a maximum of 1 Promotion Reward.
- c. After confirmation of eligibility, redemption instructions will be sent to Eligible Customers via email to the email address provided by the Eligible Customer to MoneyHero. Eligible Customers who provide inaccurate or incorrect information (as determined by MoneyHero acting in its absolute discretion) will not be able to receive any Promotion Reward.
- d. Eligibility for the Promotion Reward will be based on MoneyHero and the Product Providers' internal records. In the event of any disputes, MoneyHero reserves the right to make the final decision in its absolute discretion, which shall be binding on all users.
- e.  - (iii) are fully responsible for ensuring that the phone number provided to MoneyHero is registered for FPS and the correct phone number linked to their FPS account in their own name; and
 - (iv) acknowledge and agree that once the MoneyHero Reward Redemption Form has been submitted, the phone number provided cannot be amended, and the Cash Reward will not be re-issued to Eligible Customers who have provided incorrect phone numbers.
