

MoneyHero x 渣打銀行 私人貸款條款及細則 – 202606 提取貸款優惠(「推廣活動」)

1. 客戶凡在推廣期內通過MoneyHero成功申請指定貸款並完成以下要求的合資格客戶，將獲得推廣獎賞(定義見下文)。

2. 推廣期間

除非另有說明，推廣期間為 2026/05/29 6pm 至 2026/06/30 6pm(「推廣期間」)。

3. 推廣條款

- a. 「指定貸款」指 渣打銀行結餘轉戶計劃 或 渣打銀行 私人貸款。
- b. 「產品提供者」指 渣打銀行。

4. 合資格客戶

為了獲得推廣獎賞並成為「合資格客戶」，客戶需：

- [現金獎賞] - HK\$800現金 (直接存入FPS戶口).

- 合資格客戶將最多可獲得1個推廣獎賞。
- 在確認資格後, 兌換詳情將通過電子郵件發送至合資格客戶提供給MoneyHero的電郵地址。提供錯誤或不正確信息(由MoneyHero絕對酌情決定)的合資格客戶將無法收到任何推廣獎賞。

Terms and Conditions of MoneyHero x Standard Chartered Personal Loan – 202606 Drawdown Offer (the “Promotion”)

1. Eligible Customers who successfully apply for a Designated Loan through MoneyHero during the Promotion Period and complete the other requirements set out herein will receive a Promotion Reward (each as defined below).

2. Promotion Period

Unless otherwise specified, the promotion period of the Promotion is from 2026/05/29 6pm to 2026/06/30 6pm, dates inclusive (the “Promotion Period”).

3. For the purposes of this Promotion:

- a. “**Designated Loan**” means the Standard Chartered Debt Consolidation Program / Standard Chartered Personal Instalment Loan.
- b. “**Product Provider**” means Standard Chartered.

4. Eligible Customers

In order to receive a Promotion Reward and to comprise “**Eligible Customers**”, customers are required to:

- a. Be a Customer who is aged 18 or above, a holder of a valid Hong Kong Identity Card and with a correspondence address within Hong Kong;
- b. Fully complete and submit an application for a Designated Loan through MoneyHero using the designated link during the Promotion Period;
- c. Fully complete and submit the MoneyHero Reward Redemption Form within 7 days after successfully submitting the application for the Designated Loan within the Promotion Period; and
- d. Have their application for the Designated Loan approved by the Product Provider and complete drawdown for the Designated Loan within 3 months.

- iii. Loan amount from HK\$200,000 to HK\$299,999:
 - HK\$3,000 Wellcome Shopping Voucher; OR
 - HK\$3,000 Apple Store Gift Card; OR
 - HK\$2,400 (Deposited via FPS Account) (“Cash Reward”).

- iv. Loan amount from HK\$100,000 to HK\$199,999:
 - HK\$1,000 Wellcome Shopping Voucher; OR
 - HK\$1,000 Apple Store Gift Card; OR
 - HK\$800 (Deposited via FPS Account) (“Cash Reward”).

- b. Eligible Customers will receive a maximum of 1 Promotion Reward.
- c. After confirmation of eligibility, redemption instructions will be sent to Eligible Customers via email to the email address provided by the Eligible Customer to MoneyHero. Eligible Customers who provide inaccurate or incorrect information (as determined by MoneyHero acting in its absolute discretion) will not be able to receive any Promotion Reward.
- d. Eligibility for the Promotion Reward will be based on MoneyHero and the Product Providers’ internal records. In the event of any disputes, MoneyHero reserves the right to make the final decision in its absolute discretion, which shall be binding on all users.

 - (iv) acknowledge and agree that once the MoneyHero Reward Redemption Form has been submitted, the phone number provided cannot be amended, and the Cash Reward will not be re-issued to Eligible Customers who have provided incorrect phone numbers.
