## 4. Eligible Customers

- c. Fully complete and submit the MoneyHero Reward Redemption Form within seven (7) days after successfully submitting the loan application during the Promotion Period; and
- d. Have their application for the Designated Loan approved by the Product Provider and complete drawdown for the loan within one (1) month from the date of loan approval by the Product Provider.
