

MoneyHero x UA亞洲聯合財務(UA) 私人貸款條款及細則 – 202602申請獎勵(無須提取貸款) (「推廣活動」)

1. 客戶於推廣期內經指定MoneyHero網頁成功申請UA亞洲聯合財務(UA)私人貸款(「指定貸款」), 並留下有效聯繫資訊, 由 UA 客戶服務人員成功聯繫, 其貸款申請獲UA確認, 及成功遞交MoneyHero獎賞換領表格方可獲享優惠。

2. 推廣期

除非另有說明, 推廣活動的推廣期為 2026/01/30 6pm 至 2026/02/28 11:59pm, 包括首尾兩日(「推廣期」)。

3. 推廣條款

- a. 「指定貸款」指 UA i-Money 特快網上私人貸款 或 UA i-Money 特快業主網上私人貸款 或 UA 或【全年0息[^]】i-Money 網上錢私人貸款。
- b. 「貸款提供者」UA亞洲聯合財務(UA)。

4. 合資格客戶

為了獲得推廣獎賞並成為「合資格客戶」, 客戶需滿足以下條件:

- a. 為年滿18歲或以上、持有有效香港身份證及在香港有通訊地址的客戶;
- b. 在被重定向至貸款提供者網站之前, 向MoneyHero提供有效的電郵地址;

 - v. UA 咭數一筆清 - DCMHXXXXXXXXXXXXX
- g. 申請人必須留下有效聯繫資訊, 並須由 UA 客戶服務人員成功聯繫, 方可合資格; 及
- h. 只限於貸款結果為「獲批並接受」或「不獲批核」之申請, 方可合資格獲得獎賞。例子: 客戶提交貸款申請後, 系統顯示申請狀態為「取消(Cancel)」, 不論取消原因為(i)貸款機構取消 或(ii)申請人取消/撤回(包括但不限於對最終貸款批核結果的金額、利息或期數之異議), 該申請均不屬於「獲批並接受」或「不獲批核」之結果, 因此不合資格獲得獎賞。

5. 推廣獎賞及兌換

Terms and Conditions of MoneyHero x United Asia Finance (UA) Personal Loan – 202602 Application incentive (the “Promotion”)

1. Customers who successfully apply for a United Asia Finance (UA) Personal Loan (a “Designated Loan”) via MoneyHero, have their application for a Designated Loan confirmed by United Asia Finance (UA) , leave valid contact information and must be contacted by UA Customer Service Officer successfully, and submit the MoneyHero Reward Redemption Form within the specified period will receive a Promotion Reward.

2. Promotion Period

Unless otherwise specified, the promotion period of the Promotion is from 2026/01/30 6pm to 2026/02/28 11:59pm, dates inclusive (the “Promotion Period”).

3. For the purposes of this Promotion

“Designated Loan” means to UA i-Money Express Online Personal Loan / UA i-Money Express Online Personal Loan for Property Owner / 【Year-Round 0% Interest[^]】i-Money Internet Personal Loan.

“Product Provider” means United Asia Finance (UA) .

4. Eligible Customers

In order to receive a Promotion Reward and to comprise “Eligible Customers”, customers are required to:

- a. Be a Customer who is aged 18 or above, a holder of a valid Hong Kong Identity Card and with a correspondence address within Hong Kong;
- b. Provide a valid email address to MoneyHero prior to being redirected to the Product Provider’s website;
- c. Fully complete and submit an application for a Designated Loan through MoneyHero using the designated link during the Promotion Period;
- d. Fully complete and submit the MoneyHero Reward Redemption Form within 7 days after successfully completing the application for the Designated Loan during the Promotion Period;
- e. Submit all documents to the Product Provider and have their application for the Designated Loan confirmed by the Product Provider;
- f. Provide the correct format of Application Reference No. while submitting redemption form, this no. can be found on the Thank You page after complete application is submitted;

 - ii. UA i-Money Express Online Personal Loan - IMMXXXXXXXXXXXXX
 - iii. UA Civil Servants and Professionals Express Loan - CSPMHXXXXXXXXXXXXX
 - iv. UA i-Money Express Online Personal Loan for Property Owner - IMMXXXXXXXXXXXXX
 - v. UA Debts Consolidation Loan - DCMHXXXXXXXXXXXXX
- g. Leave valid contact information and must be contacted by UA Customer Service Officer successfully; and

- h. Eligibility for rewards is restricted to applications with loan results of "Disbursed" or "Rejected". Example: After customer submit the loan application, if the system shows the application status as "Cancelled", regardless of whether the cancellation is due to (i) cancellation by the lending institution or (ii) cancellation/withdrawal by the applicant (including but not limited to any objection to the final approved loan amount, interest rate, or repayment tenor), such applications shall not be regarded as an outcome of "Disbursed" or "Rejected" and is therefore not eligible for any reward.

5. Promotion Rewards and Redemption

- c. After confirmation of eligibility, redemption instructions will be sent to Eligible Customers via email to the email address provided by the Eligible Customer to MoneyHero. Eligible Customers who provide inaccurate or incorrect information (as determined by MoneyHero acting in its absolute discretion) will not be able to receive any Promotion Reward.
- d. Eligibility for the Promotion Reward will be based on MoneyHero and the Product Providers' internal records. In the event of any disputes, MoneyHero reserves the right to make the final decision in its absolute discretion, which shall be binding on all users.

 - (iii) are fully responsible for ensuring that the phone number provided to MoneyHero is registered for FPS and the correct phone number linked to their FPS account in their own name; and
 - (iv) acknowledge and agree that once the MoneyHero Reward Redemption Form has been submitted, the phone number provided cannot be amended, and the Cash Reward will not be re-issued to Eligible Customers who have provided incorrect phone numbers.
