

MoneyHero x WeLab 私人貸款條款及細則 – 202602優惠(無須提取貸款) (「推廣活動」)

1. 新客戶凡在推廣期內通過MoneyHero成功申請指定貸款並完成以下要求的合資格客戶，將獲得推廣獎賞(定義見下文)。

2. 推廣期間

除非另有說明，推廣期間為 2026/01/30 6pm 至 2026/02/27 6pm (「推廣期間」)。

3. 推廣條款

- a. 「指定貸款」指 WeLab Bank 私人分期貸款 (稅季適用) 或 WeLab Bank 私人分期貸款 (公務員及專業人士)。
- b. 「產品提供者」指 WeLab Bank。
- c. 「合資格客戶」、「你」或「你的」指於：

 - ii. 「現有客戶」指持有效的 WeLab Bank 核心賬戶；及根據下列第3d條款，成功提交WeLab Bank 私人分期貸款申請，並於「私人貸款優惠碼」一欄填妥指定優惠碼「NLHERO」(「貸款優惠碼」)
- d. 合資格客戶於推廣期內成功根據 WeLab Bank 私人貸款(私人分期貸款及清卡數貸款)條款及細則，於 WeLab Bank 以上述指定之開戶優惠碼或貸款優惠碼成功提交私人分期貸款申請貸款額達 HK\$500,001或以上(不適用於再借／加借私人貸款)及選擇24個月或以上還款期，並於WeLab Bank App 成功上載私人貸款申請所需且有效的文件，可享以下推廣獎賞。

4. 合資格客戶

Terms and Conditions of MoneyHero x WeLab Personal Loan - Application incentive Offer (202602)

1. Eligible Customers who successfully apply for a Designated Loan through MoneyHero during the Promotion Period and complete the other requirements set out herein will receive a Promotion Reward (each as defined below).

2. Promotion Period

Unless otherwise specified, the promotion period of the Promotion is from 2026/01/30 6pm to 2026/02/27 6pm, dates inclusive (the "Promotion Period").

3. For the purposes of this Promotion:

- a. "**Designated Loan**" means the WeLab Bank Personal Instalment Loan (Suitable for Tax Season) / WeLab Bank Personal Instalment Loan (For Civil Servants and Professionals).
- b. "**Product Provider**" means WeLab Bank.
- c. "Eligible Customer(s)", "you" or "your" means:
 - a. "New Customers" who have successfully opened a Core Account at WeLab Bank Limited ("WeLab Bank", "we", "us" or "our") using referral code "NLHERO" ("Referral Code") within the Campaign Period, and have successfully submitted application for WeLab Bank Personal Instalment Loan in accordance with Clauses 3d below (Note: To be a new WeLab Bank customer means you have not terminated and/or closed your WeLab Bank Core account in the twelve (12) months prior to the commencement of the Campaign Period); OR
 - b. "Existing Customers" who own a valid Core Account at WeLab Bank, and have successfully submitted application for WeLab Bank Personal Instalment Loan using the relevant promotion code "NLHERO" ("Promotion Code") within the Campaign Period and in accordance with Clauses 3d below.
- d. Eligible Customers who successfully submitted an application for a WeLab Bank Personal Instalment Loan with loan amount of HK\$500,001 or above (not applicable for reborrow/top-up of the Loan) and minimum tenor of 24 months using the above designated Referral Code or Promotion Code in accordance with the WeLab Bank Personal Loan (Personal Instalment Loan & Card Debt Consolidation Loan) Terms and Conditions within the Campaign Period for the first time, and upload the required and valid documents for the loan application via WeLab Bank App can enjoy the below Promotion Reward.

4. Eligible Customers

In order to receive a Promotion Reward and to comprise "Eligible Customers", customers are required to:

- a. Be a New Customer who is aged 18 or above, a holder of a valid Hong Kong Identity Card and with a correspondence address within Hong Kong;
- b. Minimum annual salary requirement is HK\$120,000;

- c. Fully complete and submit an application for a Designated Loan through MoneyHero using the designated link and designated promo code during the Promotion Period;
- d. Fully complete and submit the MoneyHero Reward Redemption Form within 7 days after successfully submitting the application for the Designated Loan within the Promotion Period; and
- e. Submit all documents to the Product Provider and have their application for the Designated Loan confirmed by the Product Provider.

- c. After confirmation of eligibility, redemption instructions will be sent to Eligible Customers via email to the email address provided by the Eligible Customer to MoneyHero.
