

MoneyHero x WeLab 私人貸款條款及細則 – 202606 申請優惠 (無須提取貸款) (「推廣活動」)

1. 新客戶凡在推廣期內通過MoneyHero成功申請指定貸款並完成以下要求的合資格客戶，將獲得推廣獎賞 (定義見下文)。

2. 推廣期間

除非另有說明，推廣期間為 2026/05/29 6pm 至 2026/06/30 6pm (「推廣期間」)。

3. 推廣條款

- a. 「指定貸款」指 WeLab Bank 清卡數貸款。
- b. 「產品提供者」指 WeLab Bank。
- c. 「合資格客戶」、「你」或「你的」指於：
 - a. 新客戶(「新開戶」) 於推廣期內於「優惠／推薦碼」一欄填妥指定優惠碼「NLHERO」(「開戶優惠碼」)成功於 WeLab Bank Limited開立核心賬戶；並已根據以下第3d條款，成功提交WeLab Bank 清卡數貸款申請，「新開戶」指你在推廣期開始前的十二(12)個月內未曾終止和/或關閉你的 WeLab Bank 核心賬戶。或
 - b. 「現有客戶」指持有效的 WeLab Bank 核心賬戶；及根據下列第3d條款，成功提交WeLab Bank 清卡數貸款申請，並於「私人貸款優惠碼」一欄填妥指定優惠碼「NLHERO」(「貸款優惠碼」)
- d. 合資格客戶於推廣期內成功根據WeLab Bank 私人貸款(私人分期貸款及清卡數貸款)條款及細則，於 WeLab Bank 以上指定之開戶優惠碼或貸款優惠碼成功提交清卡數貸款申請貸款額達 HK\$500,001或以上(不適用於再借／加借私人貸款)及選擇24個月或以上還款期，並於WeLab Bank App 成功上載私人貸款申請所需且有效的文件，可享以下推廣獎賞。

4. 合資格客戶

為了獲得推廣獎賞並成為「合資格客戶」，客戶需：

Terms and Conditions of MoneyHero x WeLab Personal Loan - Application Incentive Offer (202606)

1. Eligible Customers who successfully apply for a Designated Loan through MoneyHero during the Promotion Period and complete the other requirements set out herein will receive a Promotion Reward (each as defined below).

2. Promotion Period

Unless otherwise specified, the promotion period of the Promotion is from 2026/05/29 6pm to 2026/06/30 6pm, dates inclusive (the "Promotion Period").

3. For the purposes of this Promotion:

- a. "**Designated Loan**" means the WeLab Bank Card Debt Consolidation Loan.
- b. "**Product Provider**" means WeLab Bank.
- c. "Eligible Customer(s)", "you" or "your" means:
 - a. "New Customers" who have successfully opened a Core Account at WeLab Bank Limited ("WeLab Bank", "we", "us" or "our") using referral code "NLHERO" ("Referral Code") within the Promotion Period, and have successfully submitted application for WeLab Bank Card Debt Consolidation Loan in accordance with Clauses 3d below (Note: To be a new WeLab Bank customer means you have not terminated and/or closed your WeLab Bank Core account in the twelve (12) months prior to the commencement of the Promotion Period); OR
 - b. "Existing Customers" who own a valid Core Account at WeLab Bank, and have successfully submitted application for WeLab Bank Card Debt Consolidation Loan using the relevant promotion code "NLHERO" ("Promotion Code") within the Promotion Period and in accordance with Clauses 3d below.
- d. Eligible Customers who successfully submitted an application for a WeLab Bank Card Debt Consolidation Loan with loan amount of HK\$500,001 or above (not applicable for reborrow/top-up of the Loan) and minimum tenor of 24 months using the above designated Referral Code or Promotion Code in accordance with the WeLab Bank Personal Loan (Personal Instalment Loan & Card Debt Consolidation Loan) Terms and Conditions within the Promotion Period for the first time, and upload the required and valid documents for the loan application via WeLab Bank App can enjoy the below Promotion Reward.

4. Eligible Customers

In order to receive a Promotion Reward and to comprise "Eligible Customers", customers are required to:

- a. Be a New Customer who is aged 18 or above, a holder of a valid Hong Kong Identity Card and with a correspondence address within Hong Kong;
- b. Minimum annual salary requirement is HK\$120,000;
- c. Fully complete and submit an application for a Designated Loan through MoneyHero using the designated link and designated promo code during the Promotion Period;

- d. Fully complete and submit the MoneyHero Reward Redemption Form within 7 days after successfully submitting the application for the Designated Loan within the Promotion Period;

- b. Eligible Customers will receive a maximum of 1 Promotion Reward.
- c. After confirmation of eligibility, redemption instructions will be sent to Eligible Customers via email to the email address provided by the Eligible Customer to MoneyHero. Eligible Customers who provide inaccurate or incorrect information (as determined by MoneyHero acting in its absolute discretion) will not be able to receive any Promotion Reward.
