

# MoneyHero x WeLend私人貸款 條款及細則 202602 (須提取貸款) (「推廣活動」)

1. 客戶凡在推廣期內通過MoneyHero成功申請指定貸款並完成以下要求的合資格客戶，將獲得推廣獎賞(定義見下文)。

## 2. 推廣期

除非另有說明，推廣活動的推廣期為 2026/01/30 6pm 至 2026/02/16 11:59pm, 包括首尾兩日(「推廣期」)。

## 3. 就此推廣活動而言：

a.「指定貸款」是指 WeLend 特快批核貸款 或 WeLend 私人貸款 或【MoneyHero獨家產品】WeLend「銀行用戶尊享貸款」或 WeLend 結餘轉戶貸款。

b.「產品提供者」是指 WeLend。

## 4. 合資格客戶

為了獲得推廣獎賞並成為「合資格客戶」，客戶需滿足以下條件：

- a. 為年滿18歲或以上、持有有效香港身份證及在香港有通訊地址的客戶；
- b. 在推廣期內通過MoneyHero指定連結完整填寫並提交指定貸款的申請；
- c. 在推廣期內成功提交指定貸款的申請後7天內完整填寫並提交MoneyHero獎賞換領表格；及

## 202602 MoneyHero x WeLend - Personal Loan - Drawdown Offer

1. Eligible Customers who successfully apply for a Designated Loan through MoneyHero during the Promotion Period and complete the other requirements set out herein will receive a Promotion Reward (each as defined below).

### 2. Promotion Period

Unless otherwise specified, the promotion period of the Promotion is from 2026/01/30 6pm to 2026/02/16 11:59pm, dates inclusive (the “**Promotion Period**”).

### 3. For the purposes of this Promotion:

a. “**Designated Loan**” means the WeLend Instant Personal Loan / 【MoneyHero Exclusive】WeLend “Bank Customer” Lower Interest Rate Loan / WeLend Personal Loan / WeLend Card Debt Consolidation Loan.

b. “**Product Provider**” means WeLend.

### 4. Eligible Customers

In order to receive a Promotion Reward and to comprise “**Eligible Customers**”, customers are required to:

a. Be a New Customer who is aged 18 or above, a holder of a valid Hong Kong Identity Card and with a correspondence address within Hong Kong;

b. Fully complete and submit an application for a Designated Loan through MoneyHero using the designated link during the Promotion Period; and

c. Fully complete and submit the MoneyHero Reward Redemption Form within 7 days after successfully submitting the application for the Designated Loan.

d. Have their application for the Designated Loan confirmed by the Product Provider and complete drawdown of HK\$800,000 or above, with a repayment period of 24 months or above.

### 5. Promotion Rewards and Redemption

a. Eligible Customers who complete the conditions set out in Clause 4 above will be able to select one of the following “**Promotion Rewards**”, subject to availability:
