

MoneyHero x WeLend 私人貸款 條款及細則 - 202606 提取貸款優惠 (「推廣活動」)

1. 客戶凡在推廣期內通過MoneyHero成功申請指定貸款並完成以下要求的合資格客戶，將獲得推廣獎賞(定義見下文)。

2. 推廣期

除非另有說明，推廣活動的推廣期為 2026/05/29 6pm 至 2026/06/30 6pm, 包括首尾兩日(「推廣期」)。

3. 就此推廣活動而言：

- a. 「指定貸款」是指 WeLend 特快批核貸款 或 WeLend 私人貸款 或 【MoneyHero獨家產品】WeLend「銀行用戶尊享貸款」或 WeLend 結餘轉戶貸款。
- b. 「產品提供者」是指 WeLend。

4. 合資格客戶

為了獲得推廣獎賞並成為「合資格客戶」，客戶需滿足以下條件：

- a. 為年滿18歲或以上、持有有效香港身份證及在香港有通訊地址的客戶；
- b. 在推廣期內通過MoneyHero指定連結完整填寫並提交指定貸款的申請；
- c. 在推廣期內成功提交指定貸款的申請後7天內完整填寫並提交MoneyHero獎賞換領表格；
- d. 客戶需獲貸款提供者確認其貸款申請並成功提取 HK\$80,000 或以上 貸款額，還款期為24個月或以上；及
- e. 如客戶之貸款申請經系統自動拒絕，導致未能提交所需證明文件，該申請將被視為未成功。在此情況下，客戶將不符合任何獎賞優惠之資格，而相關之獎賞資格亦將自動被取消。

5. 推廣獎賞及兌換

b. 合資格客戶將最多可獲得1個推廣獎賞。

- c. 在確認資格後，兌換詳情將通過電子郵件發送至合資格客戶提供給MoneyHero的電郵地址。提供錯誤或不正確電子郵件（由MoneyHero絕對酌情決定）的合資格客戶將無法收到任何推廣獎賞。

Terms and Conditions of MoneyHero x WeLend Personal Loan - 202606 Drawdown Offer (the “Promotion”)

1. Eligible Customers who successfully apply for a Designated Loan through MoneyHero during the Promotion Period and complete the other requirements set out herein will receive a Promotion Reward (each as defined below).

2. Promotion Period

Unless otherwise specified, the promotion period of the Promotion is from 2026/05/29 6pm to 2026/06/30 6pm, dates inclusive (the “Promotion Period”).

3. For the purposes of this Promotion:

- a. “**Designated Loan**” means the WeLend Instant Personal Loan / 【MoneyHero Exclusive】WeLend “Bank Customer” Lower Interest Rate Loan / WeLend Personal Loan / WeLend Card Debt Consolidation Loan.
- b. “**Product Provider**” means WeLend.

4. Eligible Customers

In order to receive a Promotion Reward and to comprise “**Eligible Customers**”, customers are required to:

- a. Be a New Customer who is aged 18 or above, a holder of a valid Hong Kong Identity Card and with a correspondence address within Hong Kong;
- b. Fully complete and submit an application for a Designated Loan through MoneyHero using the designated link during the Promotion Period;
- c. Fully complete and submit the MoneyHero Reward Redemption Form within 7 days after successfully submitting the application for the Designated Loan;
- d. Have their application for the Designated Loan confirmed by the Product Provider and complete drawdown of HK\$80,000 or above, with a repayment period of 24 months or above; and
- e. In the event that a customer’s loan application is automatically declined by the system, resulting in the failure to submit the required supporting documents, such application shall be deemed unsuccessful. Under such circumstances, the customer shall not be eligible for any promotional offers, and any related eligibility shall be automatically forfeited.

- HK\$800 (Deposited via FPS Account) (“Cash Reward”).
- ii. Loan amount from HK\$500,001 or above + Repayment period 24 months or above:
- HK\$3,000 Wellcome Shopping Voucher; OR
 - HK\$3,000 Fortress Cash Voucher; OR
 - HK\$2,800 (Deposited via FPS Account) (“Cash Reward”).
- b. Eligible Customers will receive a maximum of 1 Promotion Reward.
- c. After confirmation of eligibility, redemption instructions will be sent to Eligible Customers via email to the email address provided by the Eligible Customer to MoneyHero. Eligible Customers who provide inaccurate or incorrect email address (as determined by MoneyHero acting in its absolute discretion) will not be able to receive any Promotion Reward.
- d. Eligibility for the Promotion Reward will be based on MoneyHero and the Product Providers’ internal records. In the event of any disputes, MoneyHero reserves the right to make the final decision in its absolute discretion, which shall be binding on all users.
- e. If the application for the Designated Loan is not made via the designated link, or an ad-blocker, tracking blocker or incognito mode is enabled during the application process, it may not be counted as valid and may lead to the user not being eligible for any Promotion Reward. - g. The Cash Reward will be distributed via FPS to the phone number provided by the Eligible Customer in the MoneyHero Reward Redemption Form. Eligible Customers:
- (i) are required to have registered for FPS using the phone number provided to MoneyHero;
 - (ii) agree to receive the Cash Reward via FPS;
 - (iii) are fully responsible for ensuring that the phone number provided to MoneyHero is registered for FPS and the correct phone number linked to their FPS account in their own name; and
 - (iv) acknowledge and agree that once the MoneyHero Reward Redemption Form has been submitted, the phone number provided cannot be amended, and the Cash Reward will not be re-issued to Eligible Customers who have provided incorrect phone numbers.
- h. By selecting a Cash Reward, Eligible Customers confirm that they are in compliance with all Anti-Money Laundering (AML) laws and regulations.
