

MoneyHero x Chief HK 條款及細則 (以下稱「推廣活動」) (202608)

1. 於推廣期內，透過MoneyHero申請指定賬戶，並獲批准且完成此處列明的其他要求的合資格客戶，將獲得推廣獎賞(各自定義如下)。

2. 推廣期

除非另有說明，推廣活動的推廣期為 2026/07/31 6pm 至 2026/08/31 6pm, 包括首尾兩日(以下稱「推廣期」)。。

3. 推廣活動相關定義

- a. 「指定賬戶」是指 致富證券。
- b. 「產品供應商」是指 致富證券。
- c. 「新客戶」是指於推廣活動的推廣期首次成功開立致富證券賬戶的用戶。
- d. 「指定邀請碼」是指 “MH8888”。

4. 合資格客戶

為獲得推廣獎賞並成為「合資格客戶」，客戶需：

- a. 成為年滿18歲或以上，持有有效香港身份證並擁有香港通訊地址的新客戶；
- b. 在被重定向到信用卡提供者網站前向 MoneyHero 提供有效的電子郵件地址；
- c. 在推廣期內透過MoneyHero使用指定連結及指定優惠碼完整填寫並提交指定賬戶的申請；
- d. 在推廣期內成功提交指定賬戶的申請後的7天內(無論如何不得遲於2026/09/07)完整填寫並提交 MoneyHero獎賞兌換表格，包括在MoneyHero獎賞兌換表格的「電郵地址」部分提供其有效電郵地址；
- e. 其指定賬戶的申請需獲產品供應商批准，並在2026/08/31 6pm或之前完成開戶手續，根據產品供應商的系統記錄；及
- f. 為獲得某些推廣獎賞，需在指定賬戶中存入至少HK\$10,000。

5. 推廣獎賞及兌換

- a. 完成上述第4條規定條件的合資格客戶，根據所達成的條件(視供應情況而定)，可選擇以下「推廣獎賞」之一：
 - i. 成功開立指定賬戶後，於開戶後7日內完成首次存入不少於HK\$10,000及至少完成一筆交易，並於其後30日內維持每日日均資產不少於HK\$10,000，可獲：

 - 1. 交易現金券以電子券形式派發，滿足資金及留存要求後一次性發放，客戶只需於「致富通」手機APP內的「致著數」系統領取，便可正式使用。

2. 交易現金券僅適用於港股、美股或股票期權（不包括月供股票、及股息再投資）的交易，使用者須先繳付交易佣金，其實際的扣減交易佣金(即採用「先收後回」的形式)，會於扣減期完結後的兩週後，以現金方式發放於客戶的港股交易賬戶中。
3. 交易佣金以港元計算，如屬非港元交易，其交易佣金金額將根據由致富不時全權釐定的外匯兌換率折算至等值港元計算。假設例子說明，客戶於10月31日開戶，並已於11月15日領取了交易現金券。該客戶隨後30日內實際產生的佣金超過所使用的交易現金券面值，預計於兩週後以現金方式返還。
4. 佣金至客戶賬戶中，實際返還金額不超過交易現金券價值。

- b. 合資格客戶將最多獲得1個推廣獎賞。

6. 一般推廣條款

- a. 此推廣活動由MoneyHero Global Limited（「MoneyHero」）組織。參與此推廣活動即表示用戶同意受這些條款和細則約束。
- b. 如有任何爭議，MoneyHero保留在其全權酌情下作出最終決定的權利，該決定對所有用戶具有約束力。

Terms and Conditions of MoneyHero x Chief HK (the “Promotion”) (202608)

1. Eligible Customers who apply for a Designated Account through MoneyHero during the Promotion Period, are approved for the same and complete the other requirements set out herein will receive a Promotion Reward (each as defined below).

2. Promotion Period

Unless otherwise specified, the promotion period of the Promotion is from 2026/07/31 6pm to 2026/08/31 6pm, dates inclusive (the “Promotion Period”).

3. For the purposes of this Promotion:

- a. **“Designated Account”** means the Chief Securities Limited.
- b. **“Product Provider”** means Chief Securities Limited.
- c. **“New Customer”** means Customers who have not opened a Chief Securities Account prior to their application for a Designated Securities Account as part of this Promotion.
- d. **“Promo code”** means “MH8888”.

4. Eligible Customers

In order to receive a Promotion Reward and to comprise **“Eligible Customers”**, customers are required to:

- a. Be a New Customer who is aged 18 or above, a holder of a valid Hong Kong Identity Card and with a correspondence address within Hong Kong;
- b. Provide a valid email address to MoneyHero prior to being redirected to the Product Provider’s website;
- c. Fully complete and submit an application for a Designated Account through MoneyHero using the designated link and designated promo code during the Promotion Period;
- d. Fully complete and submit the MoneyHero Reward Redemption Form within 7 days after successfully submitting the application of the Designated Account within the Promotion Period (and in any event no later than 2026/09/07), including providing their email address in the “Email Address” section of the MoneyHero Reward Redemption Form;
- e. Have their application for the Designated Account approved by the Product Provider and complete the account opening procedure on or before 2026/08/31 6pm, according to the Product Provider’s system records; and
- f. In order to receive certain Promotion Rewards, deposit at least HK\$10,000 into the Designated Account.

5. Promotion Rewards and Redemption

- a. Eligible Customers who complete the conditions set out in Clause 4 above will be able to select one of the following “Promotion Rewards”, depending on the criteria fulfilled, subject to availability:
 - i. Upon successful opening of the designated account, customers must, within 7 days from the account opening date, complete an initial deposit of no less than HK\$10,000 and complete

at least one transaction, and maintain a daily average balance of no less than HK\$10,000 for 30 consecutive days thereafter to be eligible for:

- OTO S-GUN Wireless Massage Gun (SG-300) (value at HK\$1,199); OR
- HK\$400 Apple Store Gift Card; OR
- HK\$600 Wellcome Shopping Voucher; OR
- HK\$600 HKTVMall e-Shopping Voucher; OR
- 4,000 Max Miles.

1. The Trading Cash Voucher is distributed in electronic form and will be issued in a one-off payment once the funding and retention requirements are fulfilled. Customers can redeem the voucher via the「致著數」system in the “Chief Trader” mobile app to activate and start using it.
2. The Trading Cash Voucher is only applicable to transactions involving Hong Kong stocks, U.S. stocks, or stock options (excluding Monthly Stock Savings Plans and Dividend Reinvestment). Customers must first pay the transaction commission, and the equivalent rebate (i.e. “pay first, rebate later”) will be credited in cash to the customer’s Hong Kong stock trading account within two weeks after the rebate period ends.
3. Commissions are calculated in Hong Kong Dollars (HKD). For non-HKD transactions, the commission amount will be converted into the equivalent HKD amount based on the foreign exchange rate determined solely by Chief Securities from time to time. For instance, a customer opens an account on October 31 and redeems a Trading Cash Voucher on November 15. If the customer generates commission expenses exceeding the face value of the Trading Cash Voucher within the following 30 days, the corresponding cash rebate will be credited to the customer’s account approximately two weeks later.
4. The total rebate amount credited to the customer’s account will not exceed the face value of the Trading Cash Voucher.

b. Eligible Customers will receive a maximum of 1 Promotion Reward.

c. For the avoidance of doubt, in order to comprise “Eligible Customers”, a user is only required to fund the Designated Account with the specified amount and is not required to subscribe to or purchase any securities, investment products and/or initiate any transactions or dealings of securities or investment products.

d. After confirmation of eligibility, redemption instructions will be sent to Eligible Customers via email to the email address provided by the Eligible Customer to MoneyHero. Eligible Customers who provide inaccurate or incorrect information (as determined by MoneyHero acting in its absolute discretion) will not be able to receive any Promotion Reward.

f. MoneyHero and the Product Provider are not associated with the provider or manufacturer of the Promotion Reward(s) and are not responsible for any claims, damages, losses, expenses, liabilities or costs arising from usage of the Promotion Reward(s). Any enquiries regarding the Promotion Reward(s) should be directed to the provider or manufacturer.
- j. Where the Promotion Reward is a voucher for a third-party merchant, all vouchers issued are subject to the terms and conditions of the vouchers' merchants. MoneyHero shall not in any way be liable for any goods, services or the quality or performance of such goods or services supplied by any third-party merchant, site or service provider.
- k. The recommended retail values of the Promotion Rewards provided above are for reference purposes only and are subject to change by the issuing merchant, over which MoneyHero has no control.
- l. Users who successfully apply for a Designated Account and submit the MoneyHero Reward Redemption Form but are not approved by the Product Provider will not be able to receive any Promotion Reward.

By selecting Max Miles Reward, eligible customers:
 - i. Must register a HeyMax account using the email address provided to MoneyHero;
 - ii. Are solely responsible for ensuring that the email address provided to MoneyHero has been used to register a HeyMax account, and that it is the correct email address associated with their own HeyMax account.

6. General Promotion Terms

- a. This Promotion is organised by MoneyHero Global Limited ("**MoneyHero**"). By participating in this Promotion, users agree to be bound by these Terms and Conditions.
- b. In the event of any disputes, MoneyHero reserves the right to make the final decision in its absolute discretion, which shall be binding on all users.
- c. MoneyHero reserves the right to amend these Terms and Conditions at any time, including changing the Promotion Period or Promotion Reward or to terminate this Promotion with or without prior notice or liability to users.

- d. In the event of any inconsistencies between these Terms and Conditions and any other materials (e.g marketing materials) relating to this Promotion, these Terms and Conditions shall prevail.
