

MoneyHero x 富途證券 HK 條款及細則 (以下稱「推廣活動」) (202607)

1. 於推廣期內，透過MoneyHero申請指定賬戶，並獲批准且完成此處列明的其他要求的合資格客戶，將獲得推廣獎賞(各自定義如下)。

2. 推廣期

除非另有說明，推廣活動的推廣期為 2026/07/17 6pm 至 2026/07/24 6pm，包括首尾兩日(以下稱「推廣期」)。

3. 推廣活動相關定義

- a. 「指定賬戶」是指富途證券戶口。
- b. 「產品供應商」是指富途證券。
- c. 「新客戶」是指於推廣活動的推廣期首次成功開立富途證券賬戶的用戶。
- d. 「指定優惠碼」是指「MHFUTU」。

4. 合資格客戶

為獲得推廣獎賞並成為「合資格客戶」，客戶需：

- DJI Osmo Pocket 4 運動相機 (標準套裝) (價值HK\$3,489) (需以換購價HK\$1,000換領); 或
- Sony PlayStation 5 PS5 Pro 遊戲主機 (價值HK\$6,502) (HK\$4,400 換購價); 或
- Dyson Airwrap i.d.™ 智能吹風造型器 HS08 (價值HK\$4,480); 或
- Dyson Supersonic Nural™ 風筒 HD16 (價值HK\$3,980); 或
- Marshall Stanmore IV 藍牙家用喇叭 (價值HK\$3,499); 或
- HK\$2,000 Apple Store 禮品卡; 或
- HK\$2,000 惠康購物現金券; 或
- HK\$2,000 HKTVMall 電子購物禮券; 或
- HK\$2,000 富途現金券 (可用於股票等交易或提取現金)*.

- b. 合資格客戶將最多獲得1個推廣獎賞。
- c. 為免產生疑問，成為「合資格客戶」只需向指定賬戶注入指定金額，無需訂閱或購買任何證券、投資產品及/或進行任何證券或投資產品的交易或交易。

Terms and Conditions of MoneyHero x Futu HK (the “Promotion”) (202607)

1. Eligible Customers who apply for a Designated Account through MoneyHero during the Promotion Period, are approved for the same and complete the other requirements set out herein will receive a Promotion Reward (each as defined below).

2. Promotion Period

Unless otherwise specified, the promotion period of the Promotion is starting from 2026/07/17 6pm until 2026/07/24 6pm, dates inclusive (the “**Promotion Period**”).

3. For the purposes of this Promotion:

- a. “**Designated Account**” means the Futu Securities Account.
- b. “**Product Provider**” means Futu.
- c. “**New Customer**” means Customers who have not opened a Futu Securities Account prior to their application for a Designated Securities Account as part of this Promotion.
- d. “**Designated Promotion Code**” means “MHFUTU”

4. Eligible Customers

In order to receive a Promotion Reward and to comprise “**Eligible Customers**”, customers are required to:

- a. Be a New Customer who is aged 18 or above, a holder of a valid Hong Kong Identity Card and with a correspondence address within Hong Kong;
- b. Fully complete and submit an application for a Designated Account through MoneyHero using the designated link and designated promotion code during the Promotion Period;
- c. ii. Successfully open a Designated Account, deposit at least HK\$80,000 into the Designated Account and maintain the same for at least 60 days, maintain daily average assets of HK\$80,000 or above:

- Nintendo Switch 2 (value of HK\$3,700) (Need to redeem at the redemption price of HK\$1,400); OR
- DJI Osmo Pocket 4 Action Camera (Standard Combo) (value of HK\$3,489) (Need to redeem at the redemption price of HK\$1,000); OR
- Sony PlayStation 5 PS5 Pro Game Console (value of HK\$6,502) (Need to redeem at the redemption price of HK\$4,400); OR
- Dyson Airwrap i.d.™ Multi-styler and Dryer HS08 (value of HK\$4,480) OR
- Dyson Supersonic Nural™ Hair Dryer HD16 (value of HK\$3,980); OR
- Marshall Stanmore IV Bluetooth Home Speaker (value of HK\$3,499); OR
- HK\$2,000 Apple Store Gift Card; OR
- HK\$2,000 Wellcome Shopping Voucher; OR
- HK\$2,000 HKTVmall e-Shopping Voucher; OR
- HK\$2,000 Futu Cash Voucher (redeemable for securities transactions or cash withdrawal)*.

b. Eligible Customers will receive a maximum of 1 Promotion Reward.

c. For the avoidance of doubt, in order to comprise “Eligible Customers”, a user is only required to fund the Designated Account with the specified amount and is not required to subscribe to or purchase any securities, investment products and/or initiate any transactions or dealings of securities or investment products.
