

MoneyHero x 富途證券「好友推薦」獎賞活動條款及細則 (202607)

(「條款及細則」)

1. 推廣活動概覽

「MoneyHero x 富途證券好友推薦推廣活動」(以下稱「推廣活動」)由 MoneyHero Global Limited(以下稱「MoneyHero」)主辦。於推廣期內，符合本條款及細則規定之富途證券現有客戶(「邀請人」)成功推薦新客戶(「被邀請人」)透過 MoneyHero 平台申請指定之富途證券賬戶，。於符合所有資格要求及本條款及細則之前提下，合資格邀請人可獲得推薦獎賞(各自定義如下)名額有限，先到先得，送完即止。

2. 推廣期

推廣活動之推廣期為 即日起 至 **2026/07/31 6pm**，包括首尾兩日(以下稱「推廣期」)。MoneyHero 保留於毋須事先通知的情況下，隨時縮短、延長、暫停或終止推廣期之權利。

3. 推廣活動相關定義

就本推廣活動而言，下列詞語具有以下涵義：

- a. 「指定賬戶」：指透過 MoneyHero 平台成功向富途證券申請並開立之富途證券賬戶。
- b. 「邀請人」：指符合本條款及細則所列資格要求之富途證券現有客戶。
- c. 「被邀請人」：指於推廣期前從未持有任何富途證券賬戶之新客戶。
- d. 「指定優惠碼」：指「MHFUTU」。
- e. 「推廣獎賞」：指每宗成功推薦可獲得之 **HK\$200 Apple Store** 禮品卡。

4. 邀請人(Referrer)合資格要求

於推廣期內，邀請人須同時符合以下所有條件，方可成為合資格邀請人並獲得推廣獎賞：

- a. 成為年滿 18 歲或以上，持有有效香港身份證並擁有香港通訊地址之客戶；
- b. 為富途證券之現有客戶(必須能提供正確之邀請人富途證券 ID)；

5. 被邀請人(Referee)合資格要求

邀請人獲得推廣獎賞之資格，須以被邀請人符合以下所有條件為前提。於推廣期內，被邀請人須同時符合以下所有條件，方可成為合資格被邀請人：

Terms and Conditions of MoneyHero x Futu HK Referral Program (202607) (the “Terms & Conditions”)

1. Promotion Overview

The “MoneyHero x Futu HK Referral Promotion” (the “**Promotion**”) is organised by MoneyHero Global Limited (“**MoneyHero**”). Under this Promotion, eligible existing customers (“**Referrer**”) of Futu Securities (“**Futu**” or the “**Product Provider**”) may refer new customers (“**Referee**”) to apply for a designated Futu Securities account via the MoneyHero platform. Subject to fulfilment of all eligibility requirements and these Terms and Conditions, eligible referrers will be entitled to receive a referral reward (“**Promotion Reward**”) on a first-come, first-served basis, while stocks last.

2. Promotion Period

The Promotion will run from now to Jul 31st, 2026, 6 PM, both dates inclusive (the “**Promotion Period**”). MoneyHero reserves the right to shorten, extend, suspend, or terminate the Promotion Period at any time without prior notice.

3. Definitions

For the purposes of this Promotion

- a. “**Designated Account**” means a Futu Securities account successfully opened with Futu via the MoneyHero platform.
- b. “**Referrer**” means an existing Futu customer who satisfies all eligibility requirements set out in these Terms and Conditions.
- c. “**Referee**” means a new customer who has not previously held any Futu Securities account prior to the Promotion Period.
- d. “**Designated Promotion Code**” means “MHFUTU”.
- e. “**Promotion Reward**” means **HK\$200 Apple Store Gift Card** for each successful referral.

4. Referrer Eligibility and Requirements

To qualify as an Eligible Referrer under this Promotion, a user must during the Promotion Period::

- a. Be aged 18 or above with a valid Hong Kong Identity Card and a Hong Kong correspondence address;
- b. Be an existing customer of Futu Securities (must have a valid Referrer's Futu Account ID);
- c. Submit the Redemption Form: Within **7 calendar days** after the Referee successfully opens an Designated Account, **fully and accurately complete and submit the designated MoneyHero Referral Reward Redemption Form**, including the Referee's Futu Account ID and application date;
- d. Ensure that all information submitted is accurate, and complete. Any incorrect, incomplete, or misleading information may result in disqualification; and
- e. A Referrer may refer multiple eligible Referees, with no limit on the number of referrals.

5. Referee Eligibility and Requirements

The Referrer's eligibility for the Promotion Reward is expressly contingent upon the Referee fulfilling all of the eligibility requirements set out below. To qualify as an Eligible Referee under this Promotion, a user must, during the Promotion Period:

- a. Be a New Customer aged 18 years or above with a valid Hong Kong Identity Card and a Hong Kong correspondence address;
- b. Apply for the Designated Account via MoneyHero using the designated promotion code “MHFUTU” during the Promotion Period;
- c. Be approved by the Product Provider and successfully complete the account opening procedure on or before **Jul 31st, 2026, 6:00 PM**, as determined by the Product Provider’s system records;
- d. Deposit at least **HK\$10,000** into the Designated Account and maintain such funds for **at least 60 consecutive days**, and be verified by the Product Provider as eligible for MoneyHero’s exclusive welcome reward;
- e. Be referred by only one (1) Referrer. In case of duplicate claims, eligibility shall be determined based on the submission time of the Referrer’s Reward Redemption Form, as recorded by MoneyHero.

6. Promotion Reward

Eligible Referrers who fulfill the conditions set out in Clauses 4 and 5 shall be entitled to receive:

- a. **HK\$200 Apple Store Gift Card** for each successful referral.

Promotion Rewards are available on a first-come, first-served basis, while stocks last.

7. Promotion Reward and Redemption Terms

- a. The general redemption process set out on the MoneyHero Website shall not apply to this Promotion. The redemption process for the Promotion Reward shall be governed solely by the Terms and Conditions of this Promotion.
- b. The redemption process shall commence only upon the Referrer’s submission of the Referral Reward Redemption Form;
- c. Upon confirmation of eligibility, redemption instructions will be sent to the email provided to MoneyHero. Submission of inaccurate or incorrect information may result in forfeiture of the Promotion Reward;
- d. Eligibility for the Promotion Reward shall be determined based on the internal records of MoneyHero and the Product Provider. In the event of dispute, MoneyHero’s decision shall be final and binding;
- e. Promotion Rewards are non-refundable, non-exchangeable, and available while stocks last. MoneyHero is not liable for the quality, supply, or maintenance of the Promotion Rewards;
- f. MoneyHero reserves the right to replace the reward with an alternative reward of similar value without prior notice;
- g. Apple Inc. is not a sponsor of, nor involved in, this Promotion. Apple Store Gift Cards are subject to Apple Inc.’s applicable terms and conditions;
- h. Redemption may take at least sixteen (16) weeks from the date of eligibility confirmation, subject to fulfilment timelines; Any queries or claims received more than six (6) months after the end of the Promotion Period will not be entertained.

8. General Promotion Terms

- a. This Promotion is organized by MoneyHero Global Limited. By participating in this Promotion, all participants agree to be bound by these Terms & Conditions.
- b. In the event of any inconsistency between these Terms & Conditions and any other materials relating to this Promotion (including but not limited to marketing or promotional materials), these Terms & Conditions shall prevail.
- c. MoneyHero reserves the right, at its sole and absolute discretion, to amend, vary, supplement, suspend, withdraw, or terminate this Promotion and/or these Terms & Conditions at any time, including changes to the Promotion Period or Promotion Reward, with or without prior notice.
- d. Participants agree to regularly review the MoneyHero website for updates to these Terms & Conditions. Continued participation in the Promotion shall constitute acceptance of the prevailing version of these Terms & Conditions.

- e. In the event of any dispute arising out of or in connection with this Promotion, MoneyHero reserves the right to make the final decision in its absolute discretion, which shall be final and binding on all participants. No appeals, enquiries, or correspondence shall be entertained.
- f. MoneyHero shall not be responsible or liable for any cancellation, suspension, withdrawal, or termination of the Promotion, and participants shall not be entitled to any compensation, damages, or losses arising directly or indirectly therefrom.

Where a Referee cancels, terminates, or otherwise fails to maintain the Designated Account or fulfil the eligibility requirements after account opening, MoneyHero reserves the right to withhold, claw back, or demand the return of the Promotion Reward or its equivalent cash value from the Referrer.
- m. Final approval of any product or account is determined solely by the Product Provider in its absolute discretion and subject to its internal credit, risk, and compliance criteria.
