

MoneyHero x HashKey 條款及細則 - (以下稱「推廣活動」) (202609)

1. 「合資格客戶」須於推廣期內透過MoneyHero申請指定帳戶，並經產品供應商批核及完成本條款所載其他要求，即可獲得由產品供應商提供之推廣獎賞(各自定義如下)。

2. 推廣期

除非另有說明，推廣活動的推廣期為 2026/08/31 6pm 至 2026/09/30 6pm，包括首尾兩日(以下稱「推廣期」)。

3. 推廣活動相關定義

- a. 「指定帳戶」是指HashKey戶口。
- b. 「產品供應商」是指HashKey Exchange。
- c. 「新客戶」是指獎勵活動對象為18歲或以上並且在2026/09/30 6pm前未曾 開通HashKey帳戶及存入資金的人士。
- d. 「指定優惠碼」是指「NWABTP」。

4. 合資格客戶

為獲得推廣獎賞並成為「合資格客戶」，客戶需：

- a. 成為年滿18歲或以上，持有有效香港身份證並擁有香港通訊地址的新客戶；
- b. 在被重定向到信用卡提供者網站前向 MoneyHero 提供有效的電子郵件地址；
- c. 在推廣期內透過MoneyHero使用指定連結及指定優惠碼完整填寫並提交指定帳戶的申請；
- d. 在推廣期內成功提交指定帳戶的申請後的7天內(無論如何不得遲於2026/10/07)完整填寫並提交 MoneyHero獎賞換領表格，包括在MoneyHero獎賞換領表格的「申請參考號碼」部分提供其Hashkey 帳戶ID；
- e. 其指定帳戶的申請需獲產品供應商批准，在2026/09/30 6pm或之前完成開戶手續，根據產品供應商的系統記錄；及
- f. 為獲得推廣獎賞，需完成開戶及身份認證(KYC)，並於14日內成功執行一(1)筆不少於HK\$100的數字資產交易(手續費不計算在內)。
- g. 成功申請是次推廣活動之指定帳戶的申請人，就同一申請不能同時享有由MoneyHero提供的優惠和其他機構提供的優惠(包括但不限於產品供應商提供的迎新優惠)。

5. 推廣獎賞及兌換

- a. 完成上述第4條規定條件的合資格客戶，根據所達成的條件(視供應情況而定)，可選擇以下「推廣獎賞」：

6. 一般推廣條款

- b. 如有任何爭議，MoneyHero保留在其全權酌情下作出最終決定的權利，該決定對所有用戶具有約束力。

Terms and Conditions of MoneyHero x HashKey - (the “Promotion”) (202609)

1. Eligible Customers who apply for a Designated Account through MoneyHero during the Promotion Period, are approved for the same by the Product Provider and complete the other requirements set out herein will receive a Promotion Reward (each as defined below) from the Product Provider.

2. Promotion Period

Unless otherwise specified, the promotion period of the Promotion is from 2026/08/31 6pm to 2026/09/30 6pm, dates inclusive (the “**Promotion Period**”).

3. For the purposes of this Promotion:

- a. “**Designated Account**” means the HashKey account.
- b. “**Product Provider**” means HashKey Exchange.
- c. “**New Customer**” means customers who are aged 18 or above and have not opened a HashKey account prior to applying for a HashKey account as part of this Promotion.
- d. “**Designated Promotion Code**” means “NWABTP”

4. Eligible Customers

In order to receive a Promotion Reward and to comprise “**Eligible Customers**”, customers are required to:

- a. Be a New Customer who is aged 18 or above, a holder of a valid Hong Kong Identity Card and with a correspondence address within Hong Kong;
- b. Provide a valid email address to MoneyHero prior to being redirected to the Product Provider’s website;
- c. Fully complete and submit an application for a Designated Account through MoneyHero using the designated link and designated promotion code during the Promotion Period;
- d. Fully complete and submit the MoneyHero Reward Redemption Form within 7 days after successfully submitting the application for the Designated Account within the Promotion Period (and in any event no later than 2026/10/07), including providing their HashKey Account ID in the “Application Reference Number” section of the MoneyHero Reward Redemption Form;
- e. Have their application for the Designated Account approved by the Product Provider (including completion of any assessments required by the Product Provider) and complete the account opening procedure on or before 2026/09/30 6pm, according to the Product Provider’s system records; and
- f. Complete account opening and identity verification (KYC), and execute one (1) digital asset transaction of no less than HK\$100 within 14 days (excluding handling fees) .
- g. This promotion cannot be combined with any other offers. The applicant who successfully applied for the designated account in this promotion provided by MoneyHero shall NOT be further entitled to other rewards in relation to the same application for the same account, including but not limited to the Welcome Offers provided by the Product Provider.

5. Promotion Rewards and Redemption

- a. Eligible Customers who complete the conditions set out in Clause 4 above will receive one of the following rewards:
 - i. Successfully complete account opening and identity verification (KYC), and execute one (1) digital asset transaction of no less than HK\$100 within 14 days (excluding handling fees) :
 - HK\$300 Apple Store Gift Card; OR
 - HK\$300 Wellcome Shopping Voucher; OR
 - HK\$300 HKTVmall e-Gift Voucher; OR
 - Ledger Nano S Plus Crypto Hardware Wallet (value at HK\$699).
- b. Eligible Customers will receive a maximum of 1 Promotion Reward.
- c. Promotion Rewards are offered by the Product Provider. Eligibility for the Promotion Reward is determined solely by the Product Provider based on the criteria set out in these Terms and Conditions and the Product Provider's internal records. Fulfilment of the Promotion Reward is handled by MoneyHero on behalf of the Product Provider. In the event of any disputes, the Product Provider reserves the right to make the final decision in its absolute discretion, which shall be binding on all users.
- d. After confirmation of eligibility by the Product Provider, redemption instructions will be sent to Eligible Customers via email to the email address provided by the Eligible Customer to MoneyHero. Eligible Customers who provide inaccurate or incorrect information (as determined by MoneyHero acting in its absolute discretion) will not be able to receive any Promotion Reward.

Please refer to these terms for further information on how to redeem Max Miles. MoneyHero assumes no liability for the goods, services, or their quality or performance, provided by any third-party merchants, websites, or service providers. By selecting Max Miles Reward, eligible customers:
 - i. Must register a HeyMax account using the email address provided to MoneyHero;
 - ii. Are solely responsible for ensuring that the email address provided to MoneyHero has been used to register a HeyMax account, and that it is the correct email address associated with their own HeyMax account.

6. General Promotion Terms
