

MoneyHero x HashKey 條款及細則 - (以下稱「推廣活動」) (202607)

1. 「合資格客戶」須於推廣期內透過MoneyHero申請指定帳戶，並經產品供應商批核及完成本條款所載其他要求，即可獲得由產品供應商提供之推廣獎賞(各自定義如下)。

2. 推廣期

除非另有說明，推廣活動的推廣期為 2026/06/30 6pm 至 2026/07/31 6pm，包括首尾兩日(以下稱「推廣期」)。

3. 推廣活動相關定義

- a. 「指定帳戶」是指HashKey戶口。
- b. 「產品供應商」是指HashKey Exchange。
- c. 「新客戶」是指獎勵活動對象為18歲或以上並且在2026/07/31 6pm前未曾 開通HashKey帳戶及存入資金的人士。
- d. 「指定優惠碼」是指「NWABTP」。

4. 合資格客戶

為獲得推廣獎賞並成為「合資格客戶」，客戶需：

- a. 成為年滿18歲或以上，持有有效香港身份證並擁有香港通訊地址的新客戶；
- b. 在被重定向到信用卡提供者網站前向 MoneyHero 提供有效的電子郵件地址；

5. 推廣獎賞及兌換

iii. 成功完成開戶並通過身份認證(KYC), 存入資金HK\$10,000或以上並留存7日, 及於30日內成功完成三(3)筆, 每筆不少於HK\$100的數字資產交易, 可獲:

- HK\$700 Apple Store 禮品卡; 或
- HK\$700 惠康購物禮券; 或
- HK\$700 HKTVMall 電子購物禮券.

- b. 合資格客戶最多可獲得一項5(a)所列之推廣獎賞。
- c. 推廣獎賞由產品供應商提供。推廣獎賞之合資格與否, 僅由產品供應商根據本條款及細則所載準則及其內部紀錄全權決定。推廣獎賞之履行將由MoneyHero代表產品供應商處理。如有任何爭議, 產品供應商保留最終全權決定權, 並對所有用戶具有約束力。

Terms and Conditions of MoneyHero x HashKey - (the “Promotion”) (202607)

1. Eligible Customers who apply for a Designated Account through MoneyHero during the Promotion Period, are approved for the same by the Product Provider and complete the other requirements set out herein will receive a Promotion Reward (each as defined below) from the Product Provider.

2. Promotion Period

Unless otherwise specified, the promotion period of the Promotion is from 2026/06/30 6pm to 2026/07/31 6pm, dates inclusive (the “**Promotion Period**”).

3. For the purposes of this Promotion:

- a. “**Designated Account**” means the HashKey account.
- b. “**Product Provider**” means HashKey Exchange.
- c. “**New Customer**” means customers who are aged 18 or above and have not opened a HashKey account prior to applying for a HashKey account as part of this Promotion.
- d. “**Designated Promotion Code**” means “NWABTP”

4. Eligible Customers

In order to receive a Promotion Reward and to comprise “**Eligible Customers**”, customers are required to:

- a. Be a New Customer who is aged 18 or above, a holder of a valid Hong Kong Identity Card and with a correspondence address within Hong Kong;
- b. Provide a valid email address to MoneyHero prior to being redirected to the Product Provider’s website;
- c. Fully complete and submit an application for a Designated Account through MoneyHero using the designated link and designated promotion code during the Promotion Period;
- d. Fully complete and submit the MoneyHero Reward Redemption Form within 7 days after successfully submitting the application for the Designated Account within the Promotion Period (and in any event no later than 2026/08/07), including providing their HashKey Account ID in the “Application Reference Number” section of the MoneyHero Reward Redemption Form;
- e. Have their application for the Designated Account approved by the Product Provider (including completion of any assessments required by the Product Provider) and complete the account opening procedure on or before 2026/07/31 6pm, according to the Product Provider’s system records; and

 - HK\$500 Apple Store Gift Card; OR
 - HK\$500 Wellcome Shopping Voucher; OR
 - HK\$500 HKTVmall e-Shopping Voucher.
 - iii. Successfully complete identity verification (KYC), open a designated account, and deposit a minimum of HK\$10,000, and maintaining it for 7 consecutive days, and successfully complete three (3) digital asset transactions of no less than HK\$100 each within 30 days, you can get:
 - HK\$700 Apple Store Gift Card; OR
 - HK\$700 Wellcome Shopping Voucher; OR
 - HK\$700 HKTVmall e-Shopping Voucher.
- b. Eligible Customers will receive a maximum of 1 Promotion Reward.
- c. Promotion Rewards are offered by the Product Provider. Eligibility for the Promotion Reward is determined solely by the Product Provider based on the criteria set out in these Terms and Conditions and the Product Provider's internal records. Fulfilment of the Promotion Reward is handled by MoneyHero on behalf of the Product Provider. In the event of any disputes, the Product Provider reserves the right to make the final decision in its absolute discretion, which shall be binding on all users.
- d. After confirmation of eligibility by the Product Provider, redemption instructions will be sent to Eligible Customers via email to the email address provided by the Eligible Customer to MoneyHero.
