

【MoneyHero x 華泰漲樂全球通】之推廣條款及細則 (202609)

推廣期

除特別註明外，推廣期由 **2026/08/31 6pm 至 2026/09/30 6pm** (香港時間)，包括首尾兩日(「推廣期」)。

參加資格

要取得獎賞資格，需滿足以下全部條件：
