

# MoneyHero x OSL HK 條款及細則 (以下稱「推廣活動」) (202604)

1. 於推廣期內，透過MoneyHero申請指定賬戶，並獲批准且完成此處列明的其他要求的合資格客戶，將獲得推廣獎賞(各自定義如下)。

## 2. 推廣期

除非另有說明，推廣活動的推廣期為 2026/03/31 6pm 至 2026/04/30 6pm, 包括首尾兩日(以下稱「推廣期」)。

## 3. 推廣活動相關定義

- a. 「指定賬戶」是指OSL戶口。
- b. 「產品供應商」是指OSL證券。

- HK\$500 惠康購物現金券 (由MoneyHero發放) + 888 HKD等值BTC (由OSL發放); 或
- HK\$500 HKTVmall 電子購物禮券 (由MoneyHero發放) + 888 HKD等值BTC (由OSL發放); 或
- 5,000 Max Miles 飛行里數 (由MoneyHero發放) + 888 HKD等值BTC (由OSL發放); 或
- Ledger Nano S Plus 加密貨幣硬體錢包 (價值HK\$699) (由MoneyHero發放) + 888 HKD等值BTC (由OSL發放).

iii. 如果成功開立指定帳戶並通過身份認證(KYC), 首次入金后14天內存入至少HK\$800,000並在滿額后存放30日, 可獲:

- HK\$500 Apple Store 禮品卡 (由MoneyHero發放) + 1,888 HKD等值BTC (由OSL發放); 或
- HK\$500 惠康購物現金券 (由MoneyHero發放) + 1,888 HKD等值BTC (由OSL發放); 或
- HK\$500 HKTVmall 電子購物禮券 (由MoneyHero發放) + 1,888 HKD等值BTC (由OSL發放); 或
- 5,000 Max Miles 飛行里數 (由MoneyHero發放) + 1,888 HKD等值BTC (由OSL發放); 或
- Ledger Nano S Plus 加密貨幣硬體錢包 (價值HK\$699) (由MoneyHero發放) + 1,888 HKD等值BTC (由OSL發放).

b. 合資格客戶將最多獲得1個推廣獎賞。

c. 為免產生疑問, 成為「合資格客戶」只需向指定帳戶注入指定金額, 無需訂閱或購買任何證券、投資產品及/或進行任何證券或投資產品的交易或交易。

# Terms and Conditions of MoneyHero x OSL HK (the “Promotion”) (202604)

1. Eligible Customers who apply for a Designated Account through MoneyHero during the Promotion Period, are approved for the same and complete the other requirements set out herein will receive a Promotion Reward (each as defined below).

## 2. Promotion Period

Unless otherwise specified, the promotion period of the Promotion is from 2026/03/31 6pm to 2026/04/30 6pm, dates inclusive (the “Promotion Period”).

## 3. For the purposes of this Promotion:

- a. “Designated Account” means the OSL Securities Account.
- b. “Product Provider” means OSL.
- c. “New Customer” means Customers who have not opened a OSL Securities Account prior to their application for a Designated Securities Account as part of this Promotion.

## 4. Eligible Customers

- ii. If you successfully open a Designated Account and complete identity verification (KYC), deposit at least HK\$80,000 into the Designated Account within 14 days from the date of the initial deposit and maintain such balance for 30 consecutive days after reaching the required amount, you can get:
- HK\$500 Apple Store Gift Card (issued by MoneyHero) + BTC equivalent to HK\$888 (issued by OSL); OR
  - HK\$500 Wellcome Shopping Voucher (issued by MoneyHero) + BTC equivalent to HK\$888 (issued by OSL); OR

- iii. If you successfully open a Designated Account and complete identity verification (KYC), deposit at least HK\$800,000 into the Designated Account within 14 days from the date of the initial deposit and maintain such balance for 30 consecutive days after reaching the required amount, you can get:
- HK\$500 Apple Store Gift Card (issued by MoneyHero) + BTC equivalent to HK\$1,888 (issued by OSL); OR
  - HK\$500 Wellcome Shopping Voucher (issued by MoneyHero) + BTC equivalent to HK\$1,888 (issued by OSL); OR

- b. Eligible Customers will receive a maximum of 1 Promotion Reward.
- c.
