

MoneyHero x StashAway 證券 HK 條款及細則 (以下稱「推廣活動」) (202608)

1. 於推廣期內，透過MoneyHero申請指定賬戶，並獲批准且完成此處列明的其他要求的合資格客戶，將獲得推廣獎賞(各自定義如下)。

2. 推廣期

除非另有說明，推廣活動的推廣期為 2026/07/31 6pm 至 2026/08/31 6pm, 包括首尾兩日(以下稱「推廣期」)。

3. 本推廣活動而言：

- a. 「指定賬戶」是指StashAway證券戶口。
- b. 「產品供應商」是指StashAway證券。
- c. 「新客戶」是指於推廣活動的推廣期首次成功開立StashAway證券賬戶的用戶。
- d. 「指定優惠碼」是指「MH26-HK」。

4. 合資格客戶

為獲得推廣獎賞並成為「合資格客戶」，客戶需：

- a. 成為年滿18歲或以上，持有有效香港身份證並擁有香港通訊地址的新客戶；
- b. 在被重定向到信用卡提供者網站前向 MoneyHero 提供有效的電子郵件地址；
- c. 在推廣期內透過MoneyHero使用指定連結及指定優惠碼完整填寫並提交指定賬戶的申請；

5. 推廣獎賞及兌換

Terms and Conditions of MoneyHero x StashAway HK (the “Promotion”) (202608)

1. Eligible Customers who apply for a Designated Account through MoneyHero during the Promotion Period, are approved for the same and complete the other requirements set out herein will receive a Promotion Reward (each as defined below).

2. Promotion Period

Unless otherwise specified, the promotion period of the Promotion is from 2026/07/31 6pm to 2026/08/31 6pm, dates inclusive (the “**Promotion Period**”).

3. For the purposes of this Promotion:

- a. “**Designated Account**” means the StashAway Securities Account.
- b. “**Product Provider**” means StashAway.
- c. “**New Customer**” means Customers who have not opened a StashAway Securities Account prior to their application for a Designated Securities Account as part of this Promotion.
- d. “**Designated Promotion Code**” means “MH26-HK”.

4. Eligible Customers

In order to receive a Promotion Reward and to comprise “**Eligible Customers**”, customers are required to:

- a. Be a New Customer who is aged 18 or above, a holder of a valid Hong Kong Identity Card and with a correspondence address within Hong Kong;
- b. Provide a valid email address to MoneyHero prior to being redirected to the Product Provider’s website;
- c. Fully complete and submit an application for a Designated Account through MoneyHero using the designated link and designated promotion code during the Promotion Period;
- d. Fully complete and submit the MoneyHero Reward Redemption Form within 7 days after successfully completing the application for the Designated Account during the Promotion Period (and in any event no later than 2026/09/07), including providing their StashAway Account ID (8 digits) in the “Application Reference Number” section of the MoneyHero Reward Redemption Form;
- e. Have their application for the Designated Account approved by the Product Provider and complete the account opening procedure on or before 2026/08/31 6pm, according to the Product Provider’s system records; and
- f. In order to receive certain Promotion Rewards, deposit at least HK\$10,000 into the Designated Account and maintain the same for at least 60 days.

- b. Eligible Customers will receive a maximum of 1 Promotion Reward.
- c. For the avoidance of doubt, in order to comprise “Eligible Customers”, a user is only required to fund the Designated Account with the specified amount and is not required to subscribe to or purchase any securities, investment products and/or initiate any transactions or dealings of securities or investment products.
