

MoneyHero x Syfe 證券 條款及細則(202607)

1. 「合資格客戶」須於推廣期內透過MoneyHero申請指定帳戶，並經產品供應商批核及完成本條款所載其他要求，即可獲得由產品供應商提供之推廣獎賞(各自定義如下)。

2. 推廣期

除非另有說明，推廣活動的推廣期為 2026/07/07 6pm 至 2026/07/31 6pm, 包括首尾兩日(以下稱「推廣期」)。

3. 推廣活動相關定義

- a. 「指定帳戶」是指Syfe。
- b. 「產品供應商」是指Syfe。
- c. 「新客戶」是指於申請指定賬戶時並非Syfe現有客戶。
- d. 「指定投資組合」是指Syfe所提供之產品(定息寶及靈活寶除外)。

4. 合資格客戶

- DYSON HD19 Supersonic™ Travel 旅行風筒 (價值HK\$2,490)；或
- 26,000 Max Miles 飛行里數

iv. 成功開立指定帳戶，於首次存入HK\$500,000後14天內選定投資組合，並於60天內沒有提款：

- HK\$2,600 Apple Store禮品卡；或
- HK\$2,800 惠康購物禮券；或
- HK\$2,800 HKTVMall 電子購物禮券；或
- Dyson PencilWash™ 直桿洗地機 (價值HK\$2,990)；或
- 30,000 Max Miles 飛行里數

v. 成功開立指定帳戶，於首次存入HK\$1,000,000後14天內選定投資組合，並於365天內沒有提款*：

- HK\$3,100 Apple Store禮品卡；或
- HK\$3,300 惠康購物禮券；或
- HK\$3,300 HKTVMall 電子購物禮券；或
- DJI Osmo Pocket 4 運動相機 (標準套裝) (價值HK\$3,489)；或
- 35,000 Max Miles 飛行里數

Terms and Conditions of MoneyHero x Syfe - (the “Promotion”) (202607)

1. Eligible Customers who apply for a Designated Account through MoneyHero during the Promotion Period, are approved for the same by the Product Provider and complete the other requirements set out herein will receive a Promotion Reward (each as defined below) from the Product Provider.

2. Promotion Period

Unless otherwise specified, the promotion period of the Promotion is from 2026/07/07 6pm to 2026/07/31 6pm, dates inclusive (the “**Promotion Period**”).

3. For the purposes of this Promotion:

- a. “**Designated Account**” means Syfe.
- b. “**Product Provider**” means Syfe.
- c. “**New Customer**” means customers who are not existing clients of Syfe at the time of their application for the Designated Account.
- d. “**Designated Product**” means products offered by Syfe (**excluding Cash+ Fixed and Cash+ Flexi**).

4. Eligible Customers

In order to receive a Promotion Reward and to comprise “**Eligible Customers**”, customers are required to:

- a. Be a New Customer who is aged 18 or above, a holder of a valid Hong Kong Identity Card and with a correspondence address within Hong Kong;
- b. Provide a valid email address to MoneyHero prior to being redirected to the Product Provider’s website;
- c. Fully complete and submit an application for a Designated Account through MoneyHero using the designated link during the Promotion Period and input the promotion code “MH26” during the application process (as recorded in the Product Provider’s internal records);
- d. Fully complete and submit the MoneyHero Reward Redemption Form within 7 days after successfully submitting the application for the Designated Account within the Promotion Period and in any event no later than 2026/08/07, including providing their Syfe registration email in the “Email Address” section of the MoneyHero Reward Redemption Form;

 - Marshall Emberton II Bluetooth Speaker (value of HK\$1,499); OR
 - 12,000 Max Miles.
 - iii. Successfully open a Designated Account, select an investment portfolio within 14 days after the first deposit of HK\$200,000 into the Designated Account and maintain the funds without any withdrawal for 60 days:
 - HK\$2,100 Apple Store Gift Card; OR
 - HK\$2,300 HKTVmall e-Shopping Voucher; OR
 - HK\$2,300 Wellcome Shopping Voucher; OR
 - DYSON HD19 Supersonic™ Travel Hair Dryer (value of HK\$2,490); OR
 - 26,000 Max Miles.
 - iv. Successfully open a Designated Account, select an investment portfolio within 14 days after the first deposit of HK\$500,000 into the Designated Account and maintain the funds without any withdrawal for 60 days:
 - HK\$2,600 Apple Store Gift Card; OR
 - HK\$2,800 HKTVmall e-Shopping Voucher; OR
 - HK\$2,800 Wellcome Shopping Voucher; OR
 - Dyson PencilWash™ Wet Floor Cleaner (valued at HK\$2,990); OR
 - 30,000 Max Miles.
 - v. Successfully open a Designated Account, select an investment portfolio within 14 days after the first deposit of HK\$1,000,000 into the Designated Account and maintain the funds without any withdrawal for 365 days*:
 - HK\$3,100 Apple Store Gift Card; OR
 - HK\$3,300 HKTVmall e-Shopping Voucher; OR
 - HK\$3,300 Wellcome Shopping Voucher; OR
 - DJI Osmo Pocket 4 Action Camera (Standard Combo) (value of HK\$3,489); OR

- 35,000 Max Miles.

*To be eligible for this Promotion Reward, customers must make an initial deposit of not less than HKD\$1,000,000, select their investment portfolio within 14 days, and maintain an average daily asset balance of no less than HKD\$1,000,000 in their account for a period of 365 days. If a withdrawal causes the balance to fall below the required threshold, the customer will have 14 days to replenish the shortfall. Failure to do so within the specified timeframe may result in Syfe issuing a payment notice to recover the cash equivalent value of the reward received.

- e. Eligibility for the Promotion Reward will be based on MoneyHero and the Product Providers’ internal records. In the event of any disputes, MoneyHero reserves the right to make the final decision in its absolute discretion, which shall be binding on all users.
- f. If the application for the Designated Account is not made via the designated link, or an ad-blocker, tracking blocker or incognito mode is enabled during the application process, it may not be counted as valid and may lead to the user not being eligible for any Promotion Reward. MoneyHero reserves the right to withhold any Promotion Reward where, according to its records, the application was not made through MoneyHero in accordance with these Terms and Conditions.
- g. Promotion Rewards are not refundable nor exchangeable for cash or other rewards. All products and services relating to the Promotion are available while stocks last. Eligible Customers are responsible for checking the quality of the Promotion Rewards at the time of redemption. - h. In the event that a Promotion Reward is not available from MoneyHero’s suppliers or the specified Promotion Reward can no longer be purchased from official channels, MoneyHero reserves the right to replace the Promotion Reward with an alternative of similar value.
- i. MoneyHero and the Product Provider are not associated with the provider or manufacturer of the Promotion Reward(s) and are not responsible for any claims, damages, losses, expenses, liabilities or costs arising from usage of the Promotion Reward(s). Any enquiries regarding the Promotion Reward(s) should be directed to the provider or manufacturer.
- j. Where the Promotion Reward is a voucher for a third-party merchant, all vouchers issued are subject to the terms and conditions of the vouchers’ merchants. MoneyHero shall not in any way be liable for any goods, services or the quality or performance of such goods or services supplied by any third-party merchant, site or service provider.
