

MoneyHero x Syfe 證券 條款及細則(202609)

1.「合資格客戶」須於推廣期內透過MoneyHero申請指定帳戶，並經產品供應商批核及完成本條款所載其他要求，即可獲得由產品供應商提供之推廣獎賞(各自定義如下)。

2. 推廣期

除非另有說明，推廣活動的推廣期為 2026/08/31 6pm 至 2026/09/30 6pm，包括首尾兩日(以下稱「推廣期」)。

3. 推廣活動相關定義

- a. 「指定帳戶」是指Syfe。
- b. 「產品供應商」是指Syfe。
- c. 「新客戶」是指於申請指定賬戶時並非Syfe現有客戶。
- d. 「指定投資組合」是指Syfe所提供之產品(定息寶及靈活寶除外)。

4. 合資格客戶

為獲得推廣獎賞並成為「合資格客戶」，客戶需：

 - HK\$2,000 HKTVMall 電子購物禮券; 或
 - NINJA SL400 DoubleStack™ XL 雙層氣炸鍋 (價值HK\$2,299).
- iv. 成功開立指定帳戶, 於首次存入HK\$1,000,000後14天內選定投資組合, 並於365天內沒有提款*:
- HK\$3,400 Apple Store 禮品卡; 或
 - HK\$3,500 惠康購物禮券; 或
 - HK\$3,500 HKTVMall 電子購物禮券; 或
 - PHILIPS BAR300 Baristina 全自動意式咖啡機 (價值HK\$3,998).

*為符合獲得推廣獎賞資格, 客戶須於首次成功存入不少於HK\$1,000,000或以上, 於 14 日內選定其投資組合, 並於365日內確保賬戶每日平均資產不低於HK\$1,000,000。若提款導致資金低於所需門檻, 客戶將有 14日補足差額; 若未能於限期內補回, Syfe有權向客戶發出付款通知, 追收所獲之獎賞之等值現金金額。

Terms and Conditions of MoneyHero x Syfe - (the “Promotion”) (202609)

1. Eligible Customers who apply for a Designated Account through MoneyHero during the Promotion Period, are approved for the same by the Product Provider and complete the other requirements set out herein will receive a Promotion Reward (each as defined below) from the Product Provider.

2. Promotion Period

Unless otherwise specified, the promotion period of the Promotion is from 2026/08/31 6pm to 2026/09/30 6pm, dates inclusive (the “Promotion Period”).

3. For the purposes of this Promotion:

- a. **“Designated Account”** means Syfe.
- b. **“Product Provider”** means Syfe.
- c. **“New Customer”** means customers who are not existing clients of Syfe at the time of their application for the Designated Account.
- d. **“Designated Product”** means products offered by Syfe (**excluding Cash+ Fixed and Cash+ Flexi**).

4. Eligible Customers

In order to receive a Promotion Reward and to comprise **“Eligible Customers”**, customers are required to:

- a. Be a New Customer who is aged 18 or above, a holder of a valid Hong Kong Identity Card and with a correspondence address within Hong Kong;
- b. Provide a valid email address to MoneyHero prior to being redirected to the Product Provider’s website;
- c. Fully complete and submit an application for a Designated Account through MoneyHero using the designated link during the Promotion Period and input the promotion code “MH26” during the application process (as recorded in the Product Provider’s internal records);
- d.  - iii. Successfully open a Designated Account, select an investment portfolio within 14 days after depositing HK\$500,000 into the Designated Account, and make no withdrawals for 120 days:
 - HK\$1,900 Apple Store Gift Card; OR
 - HK\$2,000 Wellcome Shopping Voucher; OR
 - HK\$2,000 HKTVmall e-Gift Voucher; OR
 - NINJA SL400 DoubleStack™ XL 2-Basket Air Fryer (value at HK\$2,299).
 - iv. Successfully open a Designated Account, select an investment portfolio within 14 days after depositing HK\$1,000,000 into the Designated Account, and make no withdrawals for 365 days:
 - HK\$3,400 Apple Store Gift Card; OR
 - HK\$3,500 Wellcome Shopping Voucher; OR
 - HK\$3,500 HKTVmall e-Gift Voucher; OR
 - PHILIPS BAR300 Baristina Fully Automatic Espresso Machine Automatic Coffee Machine (value at HK\$3,998).

*To be eligible for this Promotion Reward, customers must make an initial deposit of not less than HKD\$1,000,000, select their investment portfolio within 14 days, and maintain an average daily asset balance of no less than HKD\$1,000,000 in their account for a period of 365 days. If a

withdrawal causes the balance to fall below the required threshold, the customer will have 14 days to replenish the shortfall. Failure to do so within the specified timeframe may result in Syfe issuing a payment notice to recover the cash equivalent value of the reward received.

- b. In the event of any disputes, MoneyHero reserves the right to make the final decision in its absolute discretion, which shall be binding on all users.
- c. MoneyHero reserves the right to amend these Terms and Conditions at any time, including changing the Promotion Period or Promotion Reward or to terminate this Promotion with or without prior notice or liability to users.
- d. In the event of any inconsistencies between these Terms and Conditions and any other materials (e.g marketing materials) relating to this Promotion, these Terms and Conditions shall prevail.
