

MoneyHero x Webull 條款及細則 (以下稱「推廣活動」) (202601)

1. 於推廣期內，透過MoneyHero申請指定帳戶，並獲批准且完成此處列明的其他要求的合資格客戶，將獲得推廣獎賞(各自定義如下)。

2. 推廣期

除非另有說明，推廣活動的推廣期為 2026/01/13 12pm 至 2026/01/23 12pm, 包括首尾兩日(以下稱「推廣期」)。

3. 推廣活動相關定義

- a. 「指定帳戶」是指 Webull證券戶口。
- b. 「產品供應商」是指 Webull Securities Limited。
- c. 「新客戶」是指於推廣活動的推廣期首次成功開立微牛證券賬戶及從未領取任何微牛迎新開戶獎賞的客戶。

4. 合資格客戶

- Dyson WashG1 洗地機 (價值HK\$4,680); 或
- 組合 (總價值HK\$5,978): Dyson Supersonic Nural™ 風筒 HD16 (價值HK\$3,980) + Philips 飛利浦 RO 純淨即熱飲水機 ADD6901 (價值HK\$1,998).

【^累計淨入金=累計入金金額-累計出金金額 - 累計轉出金額，不計算資產增減值部分。如活動留存期間內任何一次出金(包含資產利息)導致淨入金低於要求金額，即不符合參與活動資格;若客戶存入港幣以外貨幣或轉出以港幣以外貨幣計價的股票，Webull會以公司內部匯率進行換算。港幣:美元 = 1:0.1274，港幣:離岸人民幣 = 1: 0.8261】

- b. 合資格客戶將最多獲得1個推廣獎賞。

Terms and Conditions of MoneyHero x Webull (the “Promotion”) (202601)

1. Eligible Customers who apply for a Designated Account through MoneyHero during the Promotion Period, are approved for the same and complete the other requirements set out herein will receive a Promotion Reward (each as defined below).

2. Promotion Period

Unless otherwise specified, the promotion period of the Promotion is from 2026/01/13 12pm to 2026/01/23 12pm, dates inclusive (the “Promotion Period”).

3. For the purposes of this Promotion

- a. “**Designated Account**” means the Webull Securities Account.
- b. “**Product Provider**” means Webull Securities Limited.
- c. “**New Customer**” means Customers who have not opened a Webull Securities Account prior to their application for a Designated Securities Account as part of this Promotion.

4. Eligible Customers

In order to receive a Promotion Reward and to comprise “**Eligible Customers**”, customers are required to:

- a. Be a New Customer who is aged 18 or above, a holder of a valid Hong Kong Identity Card and with a correspondence address within Hong Kong;

 - HK\$3,000 Wellcome Shopping Voucher; OR
 - HK\$3,000 HKTVmall e-Shopping Voucher; OR

- [^Net Cumulative Deposit = Total deposit amount - total withdrawal amount - total transferred-out amount, transfer-in amount and capital gains & losses are excluded. If any withdrawal (including interest earned on assets) during the retention period of the activity causes the net deposit to fall below the required amount, it will be ineligible to participate in the promotion.
